***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No.15-K in the area bounded by

West Glenlake Avenue; the alley next east of and parallel to North  
Keystone Avenue; a line 198 feet south of and parallel to West  
Glenlake Avenue; and North Keystone Avenue,

to those of a C1-1 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
