## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

the public alley next north of West Chicago Avenue; a line 82.28 feet west of North Hermitage Avenue; West Chicago Avenue; and a line 172.49 feet west of North Hermitage Avenue

to those of a C1-1 Neighborhood Commercial District which is hereby established in the area described above.

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the B1-2 Neighborhood Shopping District classification to those of a C1-1 Neighborhood Commercial District for the area which is bounded by:

the public alley next north of West Chicago Avenue; a line 82.28 feet west of North Hermitage Avenue; West Chicago Avenue; and a line 172.49 feet west of North Hermitage Avenue

(hereafter the "Property") will be filed on or about February 26, 2014 with the Department of Planning and Development, City of Chicago by Forbidden Root, A Benefit, LLC, 444 N. Michigan Ave., Chicago, IL 60611 (hereinafter the "Applicant"). The addresses of the Property are 1742 – 50 W. Chicago Ave., Chicago, IL. The owner of the Property is Elzie Higginbottom, 2850 S. The Property currently is improved with three buildings, two small one story buildings to the north and south and a tall two story building in the center. The Application, if approved, will allow the interior of the vacant building in the center of the Property to be refurbished for use as a brewing facility with an accessory lounge for the on-premises consumption of liquor with a seating capacity of 150 seats, package sales of liquor for off-premises consumption, a kitchen and related offices and meeting areas. No off-street parking currently exists or will be provided on-site for the building. No off-street loading exists or will be provided.




