to those of a B2-3 Neighborhood Mixed-Use District which is hereby established in the area described above.

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the C1-2 Neighborhood Commercial District classification to those of a B2-3 Neighborhood Mixed-Use District for the area which is bounded by:

a line 74.69 feet north of West School Street; the public alley next east of North Western Avenue; a line 49.00 feet south of West School Street; and North Western Avenue

(hereafter the "Property") will be filed on or about February 26, 2014 with the Department of Planning and Development, City of Chicago by Chicago School Partners, LLC 30 S. Wacker Dr., Suite 2750, Chicago IL 60606 (hereinafter the "Applicant"). The addresses of the Property are 3255–59 N. Western Ave./2349–57 W. School St. & 3301–07 N. Western Ave./2348–56 W. School St., Chicago, IL. The Applicant is the owner of the Property.

The Property currently is improved with two, three story buildings. The building at 3301–07 N. Western Ave./2348–56 W. School St that is located north of West School Street contains eight dwelling units, a ground level commercial space and eight parking spaces. If the Application is approved the existing commercial space in this building will be converted to a business live/work unit, for a total of eight dwelling units, one business live/work unit and eight parking spaces. The building at 3255–59 N. Western Ave./2349–57 W. School St. that is located south of West School Street contains five dwelling units, a ground level commercial space and five parking spaces. The Application, if approved, will authorize the conversion of the commercial space in this building to a dwelling unit and a parking space will be added inside the building, for a total of six dwelling units and six parking spaces. No exterior construction is proposed.
