ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

A line 231 feet south of and parallel to East 35th Street; the public alley next east of and parallel to South Dr. Martin Luther King Jr. Drive; a line 252.80 feet south of and parallel to East 35th Street; South Dr. Martin Luther King Jr. Drive,

to those of a C3-3 Commercial, Manufacturing and Employment District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


