ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **RS-3 Residential Single-Unit District**, as shown on Map 5-J in the area bounded by:

West Wabansia Avenue, the public alley east of and parallel to North Central Park Avenue, a line 50 feet South of and parallel to West Wabansia Avenue, North Central Park Avenue.

To those of **RM-5 Residential Multi-Family District**.

SECTION 2. This ordinance takes effect after its passage and approval.

NARRATIVE DESCRIPTION FOR THE PROPOSED REZONING AT 1653-55 NORTH CENTRAL PARK AVENUE/ 3565-3575 WEST WABANSIA AVENUE

In compliance with the "Type 1" rezonings requirements, the following Narrative is provided concerning the application to change zoning for 1653-55 North Central Park Avenue/3565-3575 West Wabansia Avenue, Chicago, Illinois from RS-3 to RM-5:

Floor Area Ratio:

The proposed Townhomes will not exceed an FAR of 1.3.

Density, Lot Area per Dwelling Unit:

Each of the six (6) Townhomes will be 1860 square feet (all square footage is above grade).

Off-street Parking:

One garage parking space is provided for each of five dwelling units/Townhomes. There will be one exterior parking space. The garages are located on the east portion of the property accessible by the public alley.

Setbacks:

Per Section 17-9-0117, the **south, front yard** setback will be ten (10) feet.

Per Section 17-9-0117, the **side yard** setback will be ten (10) feet (adjoining North Central Park Avenue). The east side of the property adjoins the public alley, east and parallel to North Central Park Avenue.

Per Section 17-9-0117, the **rear yard** setback will be 10 feet. Each Townhome will have a private yard of 188 square feet.

Building Height:

The townhomes will be 31 feet 2 inches in height.
