Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to HUDSON HOME, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Awning(s) projecting over the public right-of-way adjacent to its premises known as 2825 N. Southport Ave.

Said Awning(s) at W. Wolfram & N. Southport measure(s): Exercise

One (1) at thirty-three point six seven (33.67) feet in length, and three (3) feet in width for a total of one hundred one point zero one (101.01) square feet.

Said Awning(s) at N. Southport measure(s):

One (1) at three point nine one (3.91) feet in length, and three (3) feet in width for a total of eleven point seven three (11.73) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110767 herein granted the sum of one hundred eight dollars and sixty-seven cents (\$108.67) per annum in advance.


A 25% penalty will be added for payments received after due date.


