TRAFFIC LANE – TOW AWAY ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane – Tow Away Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD TOW AWAY ZONES:

- 1 N. Monticello Avenue (east side) from W. Bloomingdale Avenue to W. Armitage Avenue; No Parking Street Cleaning, 9:00am to 3:00pm, Third (3rd) Wednesday of the Month, 4/1-11/30, weather permitting, 11/30-4/1, No Parking Tow Zone -- (13-0059725) [O2013-1354]
- 1 N. Drake Avenue (west side) from W. Bloomingdale Avenue to W. Armitage Avenue; No Parking Street Cleaning, 9:00am to 3:00pm, Third (3rd) Tuesday of the Month, 4/1-11/30, weather permitting, 11/30-4/1, No Parking Tow Zone -- (13-00397102) [O2013-1355]
- 1 N. Francisco Avenue (west side) from W. Fullerton Avenue to W. Logan Boulevard; No Parking Street Cleaning, 9:00am to 3:00pm, Fourth (4th) Thursday of the Month, 4/1-11/30, weather permitting, 11/30-4/1, No Parking Tow Zone – (13-00595051) [O2013-1463]
- 25 S. Wells Street (east side) from a point 41 feet south of W. Polk Street to a point 45 feet south thereof; No Parking Tow Zone -- (13-01848649) [O2013-5371]
- 39 3711 W. Lawrence Avenue (south side) from a point 90 feet west of N. Lawndale Avenue to a point 35 feet west thereof; No Parking Tow Zone, all times, all days --(13-01525830) [O2013-3594]
- 40 W. Winona Street (north side) from a point 260 feet east of N. California Avenue to a point 52 feet east thereof; No Parking No Stopping No Standing Anytime, tow zone -- (13-00071683) [O2012-8507]
- 47 N. Ravenswood Avenue (west side) from a point 338 feet north of W. Montrose Avenue to a point 102 feet north thereof; No Parking Tow Zone, 7:00am to 5:00pm, Monday through Friday [O2014-1396]

WARD AMEND TOW AWAY ZONES:

27 2400 W. Madison Street (between N. Western Avenue and N. Campbell Avenue); Repeal No Parking Tow Zone during Rush Hours, 7:00am to 9:00am and 4:00pm to 6:00pm, Monday through Friday [O2014-1395]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
