ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the DX-5 Downtown Mixed-Use District and DX-7 Downtown Mixed-Use District symbols and indications as shown on Map No. 1-F in an area bounded by:

West Superior Street; North LaSalle Street; the alley next south of and parallel to West Superior Street; a line 110.41 feet east of and parallel to North Wells Street; a line 105.07 feet south of and parallel to West Superior Street; North Wells Street

to the designation of DX-7 Downtown Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all DX-7 Downtown Mixed-Use District symbols and indications established in Section 1 above to the designation of Residential Business Planned Development No. ______ which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 3: This Ordinance shall be in force and effect from after its passage and due publication.








C. EXISTING LAND-USE MAP






E. PROPERTY LINE AND RIGHT OF WAY ADJUSTMENT MAP








H1. SOUTH ELEVATION ALONG ALLEY


H2. EAST ELEVATION ALONG N. LASALLE ST.




H3. NORTH ELEVATION ALONG W. SUPERIOR ST.
