ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 11-H in the area bound by

North Lincoln Avenue; a line perpendicular to North Lincoln Avenue lying 66.37 feet north of West Cuyler Avenue as measured along the west side of the North Lincoln Avenue; the alley next west of and parallel to North Lincoln Avenue; and a line perpendicular to North Lincoln Avenue lying 91.37 feet north of West Cuyler Avenue as measured along the west side of the North Lincoln Avenue

to those of a B1-3 Neighborhood Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

12. Reason for rezoning the property: The Applicant is seeking a zoning amendment in order construct a new four (4) story mixed-use building containing three (3) residential dwelling units and one (1) at grade commercial unit, with three on-site parking spaces provided at the rear of the lot.
