***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 11-F in the area bound by

a line 109.5 north of and parallel to West Gordon Terrace; a line 100 feet east of and parallel to North Clarendon Avenue; West Gordon Terrace; and North Clarendon Avenue

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
