BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance

be amended by changing all the C3-3, Commercial, Manufacturing and Employment District symbols and indications as shown on Map No. 1-G in the area bounded by:

West Fulton Market; a line 81.77 feet east of North Elizabeth Street; a line 119.84 feet south of West Fulton Market; and North Elizabeth Street,

to those of a C3-3, Commercial, Manufacturing and Employment District which is hereby established in the area described and a corresponding use district.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about April 2, 2014, the undersigned will file an application on behalf of 1245 W. Fulton, LLC (the "Applicant") for a change in zoning from C3-3, Commercial, Manufacturing and Employment District to C3-3, Commercial, Manufacturing and Employment District (the "Application") for the property commonly known as 1243 – 1249 W. Fulton Market and 225 – 235 N. Elizabeth Street (the "Property").

The Property is currently improved with an existing brick building that has a one-story section that is approximately 6,899 gross square feet and a two-story section that is approximately 5,828 gross square feet. The height of the existing building is approximately 32'-8".

If the Application is approved, the Applicant will rehabilitate and renovate the vacant building. Once the renovation is complete, the Applicant will use the Property for uses that are permitted in the C3-3, Commercial, Manufacturing and Employment District.
