ORDINANCE 200 N. MICHIGAN OWNER, LLC Acct. No. 389365 - 1 Permit No. 1112277

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 200 N. MICHIGAN OWNER, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Caisson(s) under the public right-of-way adjacent to its premises known as 201 N. Garland Ct..

Said Caisson(s) at N. Michigan Avenue measure(s):

Two (2) at one (1) foot in length, and two point five (2.5) feet in width for a total of five (5) square feet. Said caissons shall be sixty-five (650 feet in depth.

Two (2) at one (1) foot in length, and one (1) foot in width for a total of two (2) square feet. Said caissons shall be sixty-five (65) feet in depth.

Said Caisson(s) at N. Garland Court measure(s):

One (1) at one (1) foot in length, and eight (8) feet in width for a total of eight (8) square feet. Said caisson shall be sixty-five (65) feet in depth.

One (1) at one (1) foot in length, and nine point five (9.5) feet in width for a total of nine point five (9.5) square feet. Said caisson shall be sixty-five (65) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1112277 herein granted the sum of four hundred (\$400.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
