ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 24-H in area bound by

South Winchester Avenue, West 95th Street, a line 180.53 feet East and parallel to South Winchester Avenue, a line 131.14 feet South of and parallel to West 95th Street.

SECTION 2. This ordinance takes effect after its passage and approval.

NORTH ELEVATION









PERSPECTIVE DRIVING WEST ON 95TH ST.




