a line 123 feet south of and parallel to West LeMoyne Street; North Western Avenue; a line173 feet south of and parallel to West LeMoyne Street; and the alley next west of and parallel to North Western Avenue

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
