**To those of an RM4.5, Residential Multi-Unit District**

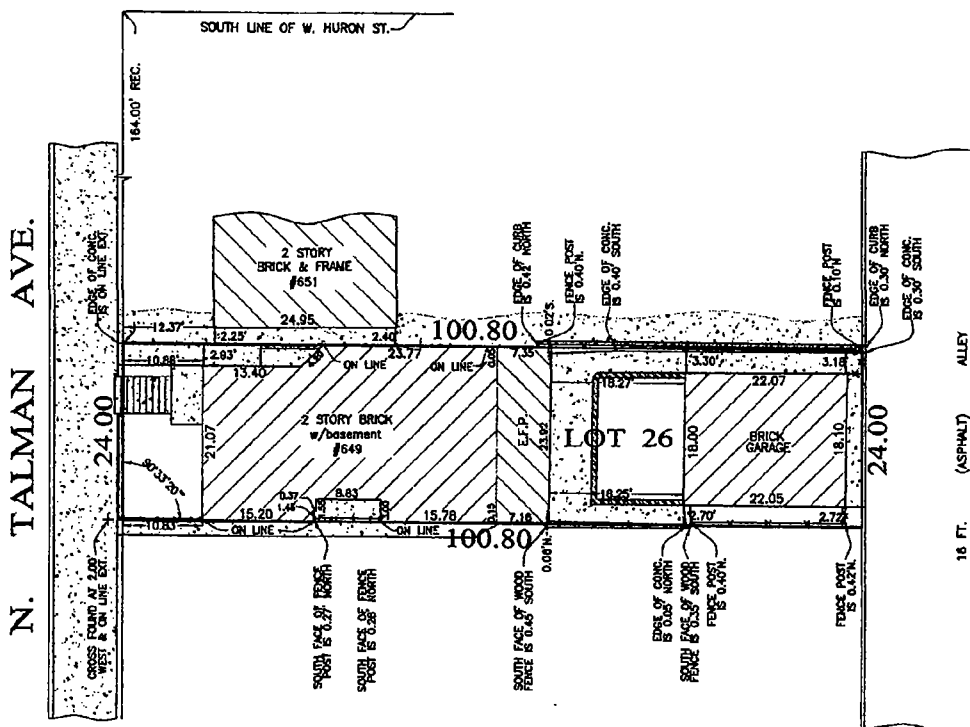
