BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-3 Community Shopping District symbols and indications as shown on Map No. 7-I in the area bound by

West Division Street; a line 159.66 feet east of and parallel to North Honore Street; the alley next south of and parallel to West Division Street; they alley next east of and parallel to North Honore Street; the alley next south of and parallel to West Division Street; and North Honore Street,

to those of a B3-3 Community Shopping District Type 1 as Amended and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The first floor of the new (proposed) building will contain three commercial/retail spaces. One of the commercial/retail spaces (14,741 sq. ft.) will be occupied by a retail grocer. Tenants for the other two commercial/retail spaces (1,962 sq. ft. and 2,003 sq. ft., respectfully) have yet to be determined. The second and third floors of the new (proposed) building will contain a total of 77 on-site garage parking spaces (37 and 40, respectively) for employees and customers of the commercial/retail tenants. The building will be masonry and corrugated metal in construction and measure 47'-4" (approx.) in height.
