#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1: Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the Residential Business Planned Development No. 1229 symbols and indications as shown on Map No. 1-E in an area bounded by:

a line 166.30 feet north of and parallel to East Lake Street; North Michigan Avenue; East Lake Street; North Garland Court

to the designation of Residential Business Planned Development No. 1229, as amended, which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development herewith attached and made a part thereof and to no others.

SECTION 2: This Ordinance shall be in force and effect from after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, for an approval under the Chicago Zoning Ordinance and an application for an amendment to Residential Business Planned Development No. 1229, please be informed that on or about June 18, 2014, I, the undersigned attorney, will file an application on behalf of the Applicant for a change in zoning from Residential Business Planned Development No. 1229 to Residential Business Planned Development No. 1229, as amended, for the property commonly known as 200-214 North Michigan Avenue, Chicago, Illinois and generally bounded by: a line 166.30 feet north of and parallel to East Lake Street,; North Michigan Avenue; East Lake Street; North Garland Court.

The Applicant proposes a technical amendment to Residential Business Planned Development No. 1229 eliminating the Upper-Level Setback FAR Bonus, reducing the FAR from 21.63 to 20.19 and reducing the building height one level from 515 feet to 489 feet. The approved development is still planned to consist of a 41 story residential building containing 402 dwelling units, approximately 24,900 square feet of retail/commercial space and 125 parking spaces.

The Applicant and Owner is 200 North Michigan Owner LLC, whose address is 1 N. Wacker Drive, Suite 2400, Chicago, Illinois.

I am the attorney for the Applicant. My address is 130 East Randolph, Suite 3800, Chicago, Illinois 60601.

Please note that the Applicant is not seeking to purchase or rezone your property. The Applicant is required by law to send you this notice because you own property located within 250 feet of the proposed development.




LANDSCAPE & GREEN ROOF PLAN Scale: N.T.S.

LEVEL 2 PLAN DIAGRAM


