ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M2-2 Light Industrial District symbols and indications as shown on Map No 1-G in an area bounded by:

West Hubbard Street; a line 183.00 feet west of and parallel to North May Street; a line 150.00 feet north of and parallel to West Hubbard Street; and a line 233.00 feet west of and parallel to North May Street

to those of a B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Section 17-13-0107(A) of the Zoning Ordinance, Title 17 of the Municipal Code of the City of Chicago, please be informed that on or about June 17, 2014, this Firm will file an application with the Department of Planning + Development for a change in zoning from a M2-2 Light Industrial District to a B2-3 Neighborhood Mixed-Use District for the property located at 1150 West Hubbard Street on behalf of 1150 West Hubbard LLC, 2436 North Western Avenue, Chicago, Illinois 60647. The principals of 1150 West Hubbard LLC are John McNaughton of the same address and Seamus Murnin, 6818 West 95th Street, Oak Lawn, Illinois 60453.

The rezoning is sought in order to allow for the development of a four-story, eight-dwelling unit building with a total of nine off-street parking spaces.
