BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood District symbols and indications as shown on Map No. 3-F in the area bounded by

North Clybourn Avenue; West Division Street; North Cleveland Avenue, the public alley next northwest of West Division Street,

to those of a C1-5 Neighborhood District.

SECTION 2. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-5 Neighborhood District symbols and indications as shown on Map No. 3-F in the area bounded by

North Clybourn Avenue; West Division Street; North Cleveland Avenue, the public alley next northwest of West Division Street,

to those of Planned Development Number _____, which is hereby established in the area described above and subject to such use and bulk regulations set forth in the Plan of Development attached hereto and to no others.

SECTION 3. This ordinance takes effect after its passage and due publication.

As you are aware, Brinshore-Michaels, operating under the name of Clydiv, LLC was selected by the City of Chicago and the Near North Working Group, as the developer of the Clybourn and Division site, owned by the City. Clydiv, LLC was selected in the HED 2011 Multi-family Funding Round to move forward with development underwriting and other reviews. Therefore, subject to your review and discretion, I have no objection to Clydiv, LLC's request for the zoning changes needed to apply for building permits and construction of the mixed use, mixed income development at Clybourn and Division, subject to our usual internal departmental review and coordination. I understand that they are requesting the approval of a planned development and a zoning change to accommodate the proposed building.

The vacant lots listed below are currently in our department's inventory, and are reserved for the Clybourn and Division development. DPD has budgeted to fund the Clybourn and Division Development in 2015 with an allocation of 9% Low Income Housing Tax Credits, Donation Tax Credits, and TIF funds. The lots will be transferred to the developer at closing of the financing.

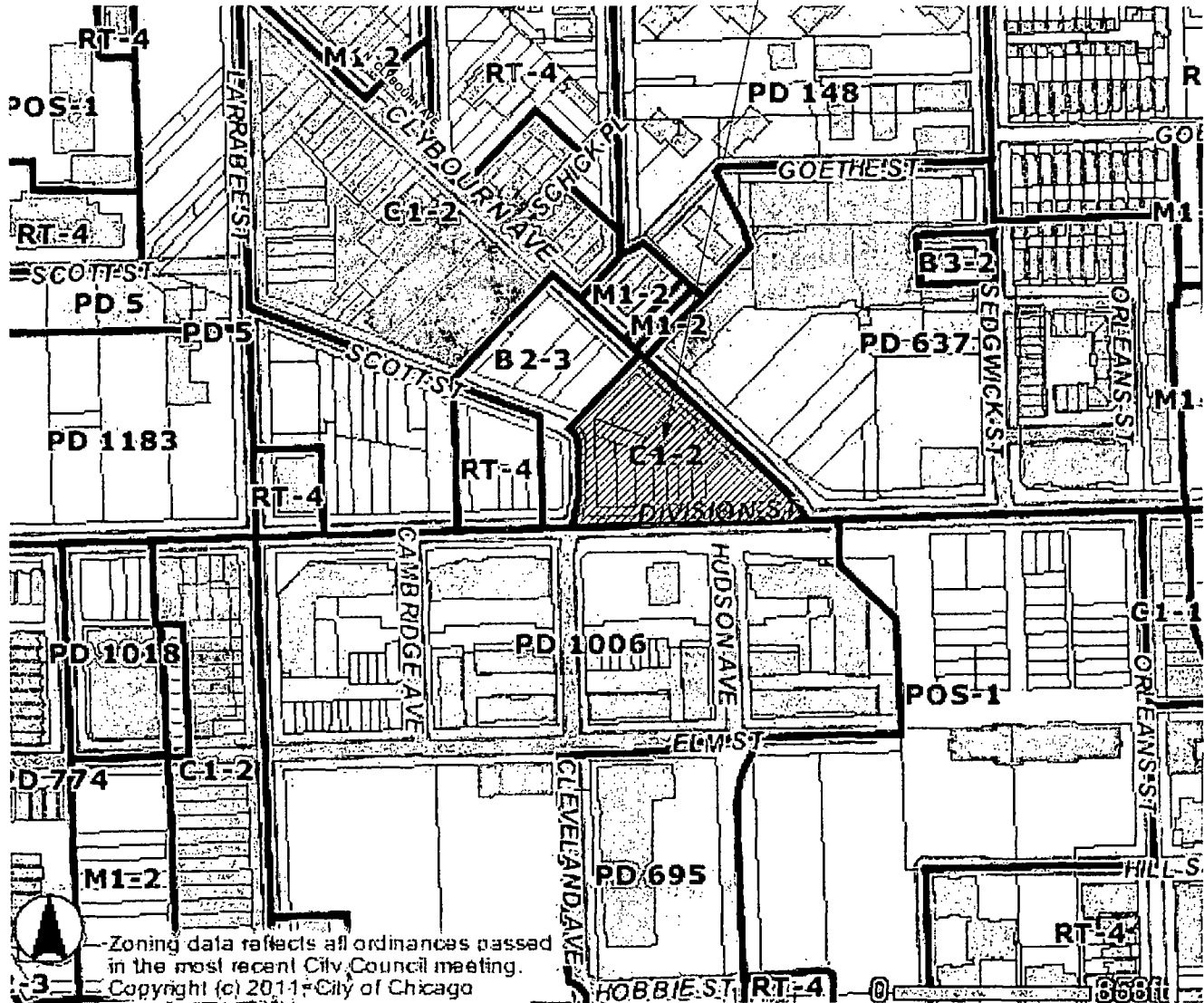

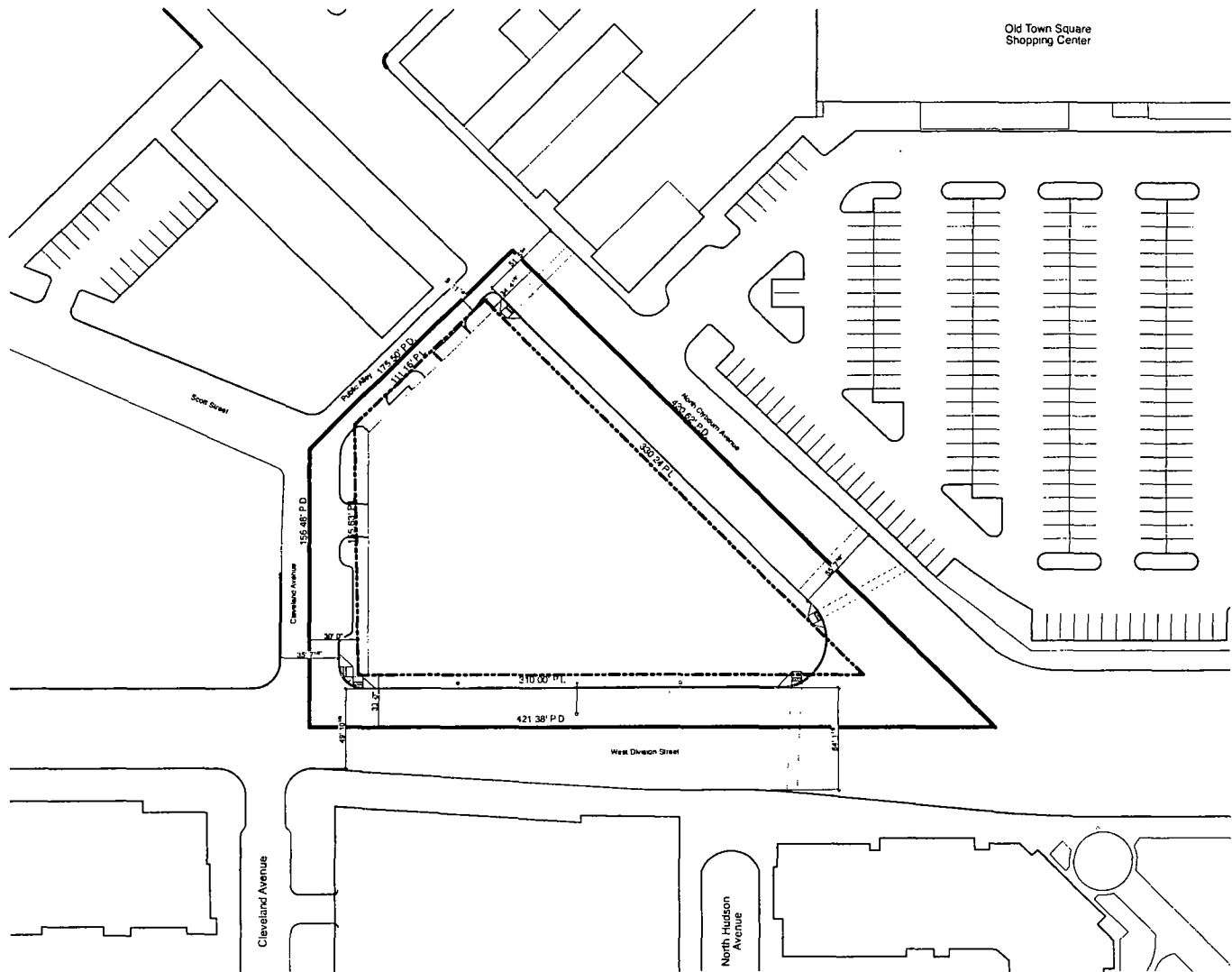
