Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Claire Cahan, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Step(s) on the public right-of-way adjacent to its premises known as 2201 W. 21st St..

Said Step(s) at W. 21st Street measure(s):

One (1) at fifty-six (56) feet in length, and point seven five (.75) feet in width for a total of forty-two (42) square feet.

Said Step(s) at S. Leavitt measure(s):

One (1) at two point nine two (2.92) feet in length, and point one seven (.17) feet in width for a total of point five (.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1113375 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

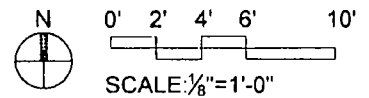
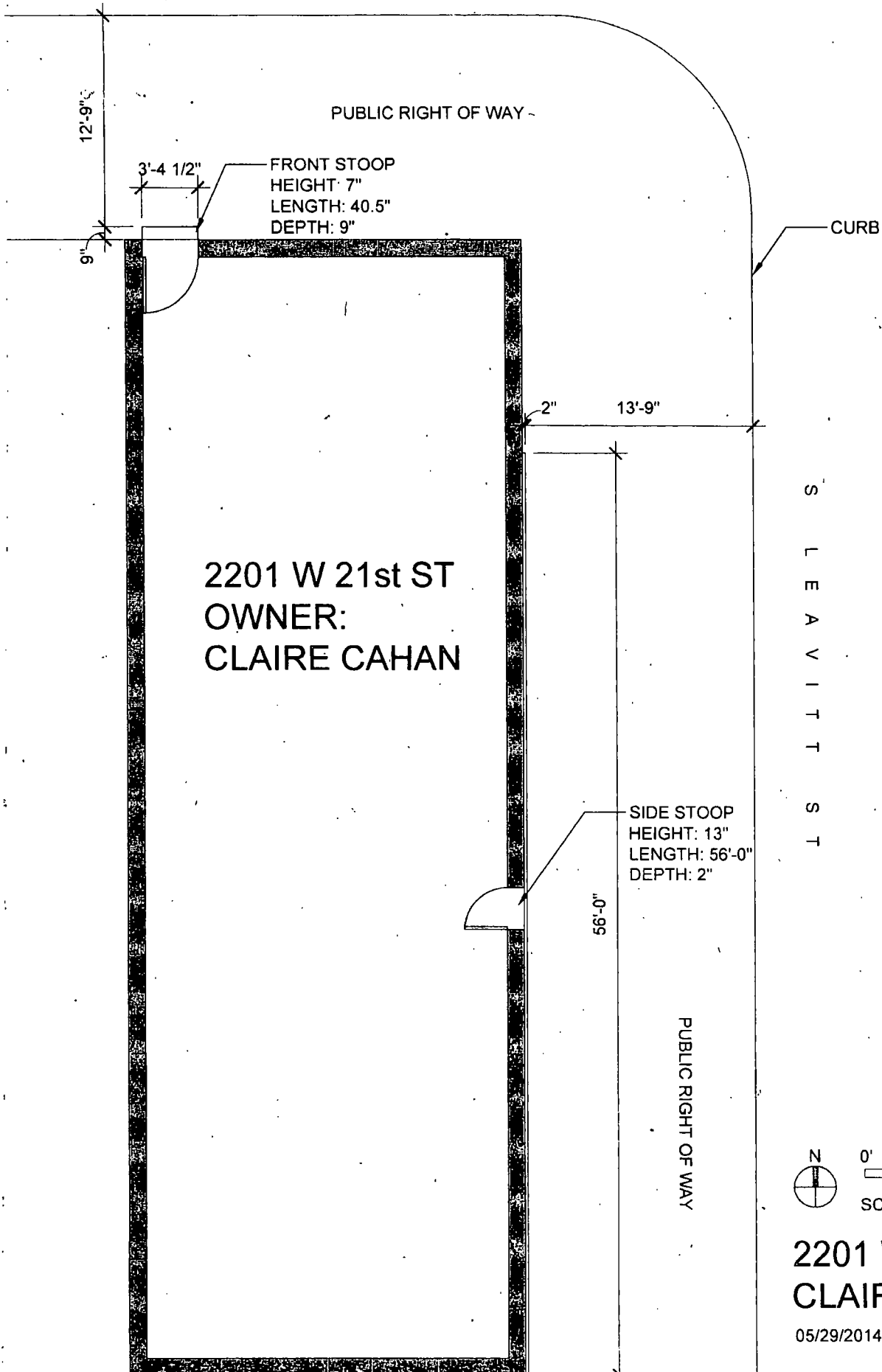
