## STREET NAME CHANGE ORDINANCE

WHEREAS, East 42<sup>nd</sup> Street is a Dedicated Public Street in Lake Park Crescent, approved July 10, 2002 by the City Council of the City of Chicago and recorded in the Office of the Recorder of Deeds of Cook County Illinois as Document No. 0030468270, being a Subdivision of part of the Northwest ¼, of Section 2, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois, and

WHEREAS, East 42<sup>nd</sup> Street, as a Dedicated Public Street, does not conform with the City of Chicago Street and Address Grid:

WHEREAS, The Chicago Department of Transportation desires to correct the name of the street so that it conforms to the City's street and address grid; Now Therefore:

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. That the name of East 42<sup>nd</sup> Street is Hereby changed to "East Bowen Avenue" lying between the East line of South Lake Park Avenue extended and the West line of South Oakenwald Avenue extended.

SECTION 2. This ordinance shall take effect and be in force from and after its passage.


Re: Proposed Street Name Change - 4<sup>th</sup> Ward
