*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to ELM STATE PROPERTY LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Caisson(s) under the public right-of-way adjacent to its premises known as 4 E. Elm St..

Said Caisson(s) at E. Elm Street measure(s):

One (1) at eleven point five (11.5) feet in length, and three point five (3.5) feet in width for a total of forty point two five (40.25) square feet.

One (1) at eleven point four two (11.42) feet in length, and three point four two (3.42) feet in width for a total of thirty-nine point zero six (39.06) square feet.

One (1) at twelve (12) feet in length, and three point nine two (3.92) feet in width for a total of forty-seven point zero four (47.04) square feet.

Said Caisson(s) at N. State Street measure(s):

One (1) at thirteen point one six (13.16) feet in length, and four point five eight (4.58) feet in width for a total of sixty point two seven (60.27) square feet.

One (1) at seven point five (7.5) feet in length, and one point five (1.5) foot in width for a total of eleven point two five (11.25) square feet.

Said Caisson(s) at Public Alley measure(s):

One (1) at three point two five (3.25) feet in length, and two point three three (2.33) feet in width for a total of seven point five seven (7.57) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1113354 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

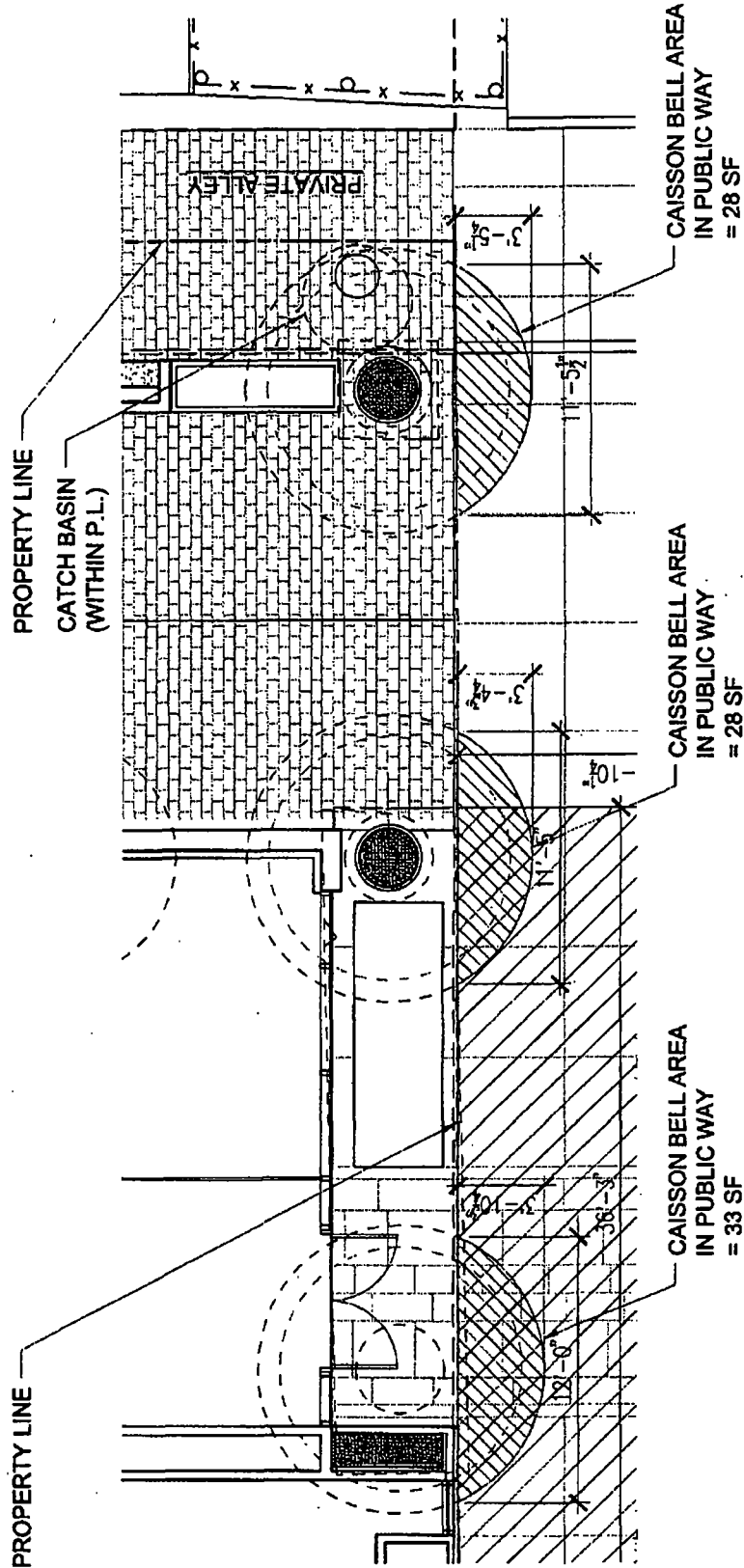
