
ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B1-3, Neighborhood Shopping District symbols as shown on Map No. 7-J in the area bounded by:

North Milwaukee Avenue; a line 367.34 feet South-East of and almost parallel to North Kimball Avenue, as measured along the southern boundary of North Milwaukee Avenue; the public alley next South-West of and parallel to North Milwaukee Avenue; North Kimball Avenue.

To those of a C1-3, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval. Common address of property: 2760-78 North Milwaukee Avenue, Chicago IL.
