SECTION 1. Title 17 of the Municipal¹Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Waterway-Industrial Planned Development No. 1165 symbols as shown on Map Numbers 6-H and 8-H in the area legally described as:

The area delineated herein as a Waterway-Industrial Planned Development ("Planned Development"), consists of approximately one million eight hundred two thousand eight hundred (1,802,800) square feet (±41.387 acres) of property as depicted on the attached Planned Development Boundary and Property Line Map ("Property"). The Property is under the single designated control and ownership of the applicant, ProLogis Park Chicago, L.L.P.
- 2. All applicable official reviews, approvals or permits that are required in connection with the Planned Development shall be obtained or authorized to be obtained by the applicant. Any dedication or vacation of streets, alleys or easements, or adjustments of rights-of-way, or consolidation or resubdivision of parcels, shall require a separate submittal and approval by the City Council.

Nothing herein shall prohibit or in any way restrict the alienation, sale or any other transfer of all or any portion of the Property or any rights, interests or obligations therein. Upon any alienation, sale or any other transfer of all or any portion of the Property or the rights therein (other than an assignment or transfer of rights pursuant to a mortgage or otherwise as collateral for any indebtedness) and solely with respect to the portion of the Property so transferred, the term "applicant" shall be deemed amended to apply to the transfere thereof (and its beneficiaries if such transferee is a land trust) and the seller or transferor thereof (and its beneficiaries if such seller or transferor is a land trust) shall thereafter be released from any and all obligations or liability hereunder. An agreement among the owners of the Property, or a covenant binding upon the owners of the Property, may designate the parties authorized to apply for future amendments, modifications or other changes to this Planned Development.

4. This plan of development consists of these sixteen (16) statements; a Bulk Regulations and Data Table; a Planned Development Boundary and Property Line Map; an Existing Zoning Map; an Existing Land Use Map; a Site Plan – 1; and a Site Plan – 2, all prepared by Spaceco Inc. dated _____; a Landscape Plan prepared by Norris Design dated _____; and typical Building Elevations prepared by Scannell Properties dated _____. Full-sized copies of the Landscape Plan and the Building Elevations are on file with the

Department Planning and Development (the "**Department**"). This Planned Development conforms to the intent and purpose of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, and all requirements thereof, and satisfies the established criteria for approval as a planned development. In any instance where a provision of the Planned Development conflicts with the Chicago Building Code, the Building Code shall control.

- 5. The following uses shall be permitted within the area delineated herein as Waterway-Industrial Planned Development Number 1165: any Permitted Use (as defined in §17-1702119 of the Chicago Zoning Ordinance) in Planned Manufacturing District Number 11, Subdistrict A, including warehousing and distribution activities, vehicle storage and towing (including fleet storage yards), accessory parking, and accessory and related uses. Portions of the Property may be used on an interim basis for construction staging and the storage of construction materials for the various phases of development of the Property.
- 6. Identification signs, on-premise signs, and temporary signs such as construction and marketing signs, shall be permitted within the Planned Development subject to the review and approval of the Department. Off-premise signs shall not be permitted in the Planned Development. The City acknowledges that there is a freestanding off-premise sign located on the Property on the west side of and adjacent to Damen Avenue. This sign is a nonconforming sign and may remain in use subject to the regulations of Section 17-15-0500 of the Chicago Zoning Ordinance and all other applicable requirements of the Municipal Code.
- 7. Any service drive or other ingress and egress shall be adequately designed and paved in accordance with the regulations of the Chicago Department of Transportation in effect at the time of construction and in compliance with the Municipal Code of Chicago. Closure of all or part of any public street or alley during demolition or construction shall be subject to review and approval of the Chicago Department of Transportation.
- 8. For purposes of floor area, floor area ratio ("F.A.R.") and building height calculations, the definitions of the Chicago Zoning Ordinance shall apply.
- 9. The improvements on the Property shall be designed, constructed and maintained in substantial conformance with the Site Plan, Landscape Plan and Building Elevations attached hereto and made a part of this Planned Development. Part II approval pursuant to Section 17-13-0610 of the Chicago Zoning Ordinance shall be issued for each individual building provided that the proposed building substantially conforms to the Site Plan prepared by Spaceco Inc. dated _____, Landscape Plan prepared by Norris Design dated _____, and the typical Building Elevations prepared by Scannell Properties dated along the Property line where it faces the Sanitary and Ship canal. Notwithstanding any statement to the contrary, this Planned Development shall be subject to the provisions of Chapter 17-11 of the Chicago Zoning Ordinance governing landscaping and screening. In any instance where a provision of this Planned Development conflicts with landscape and screening provisions of the Chicago Zoning Ordinance, the Chicago Zoning Ordinance

shall control. Nothing in this Planned Development is intended to waive the applicability of the landscape and screening provisions of the Chicago Zoning Ordinance.

- 10. The applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioner of the Department of Streets and Sanitation, the Commissioner of the Environment and the Commissioner of Buildings under Section 13-32-125 of the Municipal Code of Chicago or any other provision of that Code.
- 11. Prior to issuance by the Department of a determination pursuant to Section 17-13-0610 of the Chicago Zoning Ordinance ("Part II approval") for plans and elevations that are not in substantial conformance with the Site Plan prepared by Spaceco Inc. dated _____, Landscape Plan prepared by Norris Design dated _____, and the typical Building Elevations prepared by Scannell Properties dated _____, attached hereto as exhibits, a Site Plan for such proposed development shall be submitted to the Department for approval by the Commissioner of the Department ("Site Plan approval"). Site Plan approval is intended to assure that specific development proposals conform with this Planned Development and to assist the City in monitoring ongoing development. A Site Plan may be submitted for all or any part of the subject property (a "Development Parcel").

Following Site Plan approval, the Site Plan shall be kept on permanent file with DPD and shall be deemed to be an integral part of this Planned Development.

After Site Plan approval, the approved Site Plan may be changed or modified pursuant to the provisions of Statement Number 12 of this Planned Development.

A Site Plan shall, at a minimum, provide the following information with respect to the proposed improvements within the boundaries of a Development Parcel and including any improvements required by this Planned Development not located within the Development Parcel:

- (a) Building elevations;
- (b) Preliminary landscaping plan; and

The applicant acknowledges that it is in the public interest to design, construct and maintain the improvements on the Property in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all new buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities ("M.O.P.D.") to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
- 15. Upon Part II Review, a Part II Review Fee shall be assessed by the Department pursuant to Section 17-13-0610 of the Chicago Zoning Ordinance. The fee, as determined by the Department staff at that time, is a final and binding on the applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
- 16. This Planned Development shall expire and the zoning of the Property shall revert to the pre-existing classification of Planned Manufacturing District Number 11, Subdistrict A only if no building is constructed as contemplated herein within six (6) years following adoption of the Planned Development.
