PUBLIC WAY OPENINGS

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City can enhance public access by opening new rights of way or widening existing rights of way; and

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. PARCEL 1:

THAT PART OF LOT 25 IN BLOCK 1 IN CROCKER'S RESUBDIVISION OF THE SOUTH HALF OF THE WEST HALF OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 17, TOWNSHIP 38 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED MARCH 31, 1869 AS DOCUMENT 5264, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID LOT 25; THENCE NORTH 01 DEGREES 33 MINUTES 26 SECONDS WEST, ALONG THE WEST LINE OF SAID LOT 25, A DISTANCE OF 14.00 FEET; THENCE NORTH 88 DEGREES 28 MINUTES 55 SECONDS EAST, 124.70 FEET TO A POINT ON THE EAST LINE OF SAID LOT 25 BEING 14.00 FEET NORTH OF THE SOUTHEAST CORNER THEREOF; THENCE SOUTH 01 DEGREES 33 MINUTES 26 SECONDS EAST, ALONG SAID EAST LINE, 14.00 FEET TO THE SOUTHEAST CORNER THEREOF; THENCE SOUTH 88 DEGREES 28 MINUTES 55 SECONDS WEST, ALONG THE SOUTH LINE OF SAID LOT 25, A DISTANCE OF 124.70 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS.

A DISTANCE OF 10.00 FEET TO A POINT ON A LINE 10.00 FEET WEST OF AND PARALLEL WITH THE EAST LINE OF SAID LOTS 9 THROUGH 13 (INCLUSIVE); THENCE NORTH 01 DEGREES 32 MINUTES 38 SECONDS WEST, ALONG SAID PARALLEL LINE, 124.98 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 9 BEING 10.00 FEET WEST OF THE NORTHEAST CORNER THEREOF: THENCE NORTH 88 DEGREES 28 MINUTES 08 SECONDS EAST, ALONG SAID NORTH LINE, 10.00 FEET TO THE NORTHEAST CORNER OF SAID LOT 9; THENCE SOUTH 01 DEGREES 32 MINUTES 38 SECONDS EAST, ALONG THE EAST LINE OF SAID LOTS 9 THROUGH 13 (INCLUSIVE), 124.98 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS, CONTAINING 1.250 SQUARE FEET OR 0.0.029 ACRES, MORE OR LESS, as shaded and legally described by the words "HEREBY OPENED FOR PUBLIC RIGHT OF WAY" on the Plat hereto attached as Exhibit A, which Plat for greater certainty, is hereby made a part of this ordinance, be and the same is hereby opened to pedestrian and vehicular traffic as the same is intended for public use and the public interest will be subserved by such opening.

SECTION 2. The opening of public way is made upon the express condition that within 180 days after the passage of this ordinance, the Department of Planning and Development or its assigned agent shall deposit in the City Treasury of the City of Chicago, a

sum sufficient to defray the costs of removing and constructing paving, curb returns and street, as necessary within the area to be opened, in accordance with current Department of Transportation Construction Guidelines for construction of public way, and the Duty to Build Agreement attached as Exhibit B, hereby made a part of this ordinance

SECTION 3. The opening of public way herein provided for is also made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Department of Planning and Development or its assigned agent shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with an oversized plat as approved by the Superintendent of Maps and Plats.

SECTION 4. This ordinance shall take effect and be in force from and after its passage and publication. The opening shall take effect upon its recording.





DUTY TO BUILD AGREEMENT FOR CREATION OF A NEW ALLEY/STREET

In support of my current application with the Chicago Department of Transportation's Maps and Plats Unit, for an opening of City property, I hereby state that I am the applicant or the company agent for the applicant company involved in the project, and that I have the authority to agree to the below terms of the dedication. I am aware that I am responsible for the construction of all public and private rights of way (streets, alleys, etc) described on the Plat of Dedication.

I further understand that all rights of way (both public and private) must be built to City specifications as detailed in CDOT's <u>Regulation for Openings</u>, <u>Construction</u> and <u>Repair in the Public Way</u>.

Lastly, I understand that construction deposits will be required to assure that the work is done correctly. An inspection will be conducted by the City upon completion of the work. The City of Chicago reserves the right to require demolition and reinstallation of any facilities that are judged to be sub par or that do not adhere to the City's standards.
