ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: On behalf of the City of Chicago, the Commissioner of the Department of Fleet and Facility Management is authorized to execute a Lease with the Westside Holistic Family Services Inc., governing the City's use of property located at 4909 West Division Street by the Department of Public Health, payment of rent, and indemnification; such Lease to be approved by the Commissioner of the Department of Public Health and approved as to form and legality by the Corporation Counsel in substantially the following form:

LEASE

THIS LEASE is made and entered into this _______ day of ______, 2014 (the "Effective Date"), by and between WESTSIDE HOLISTIC FAMILY SERVICES, INC., an Illinois Not-for-Profit Corporation (hereinafter referred to as "Landlord"), and THE CITY OF CHICAGO, an Illinois Municipal Corporation and Home Rule Unit of Government (hereinafter referred to as "Tenant" or "City").

WHEREAS, Landlord is the owner of a five story building more commonly known as 4909 West Division Street (the "Building") located in Chicago, Cook County, Illinois; and

WHEREAS, Landlord has agreed to lease to Tenant, and Tenant has agreed to lease from Landlord, Suite 412, Suite 411, and a portion of Suite 401 comprised of approximately 3,400 square feet of office space located on the fourth floor of the Building as described on **Exhibit A** attached hereto and made a part hereof and to be used by the Department of Public Health to administer Tenant's clinical and counseling programs.

NOW THEREFORE, in consideration of the covenants, terms, and conditions set forth herein, the parties hereto agree and covenant as follows:

SECTION 1. GRANT

Landlord hereby leases to Tenant the following described premises situated in the City of Chicago, County of Cook, State of Illinois, to wit:

Suite 412, Suite 411, and a portion of Suite 401 comprised of approximately 3,400 square feet of office space located on the fourth floor of 4909 West Division Street, Chicago, Illinois as described on **Exhibit A** attached hereto and made a part hereof (the "**Premises**").

SECTION 2. TERM

The term of this Lease ("**Term**") shall begin on the Date of Occupancy (as defined hereunder) and shall end on December 31, 2021, unless sooner terminated as set forth in this Lease.

SECTION 3. <u>RENT, TAXES AND UTILITIES</u>

3.1 <u>Rent</u>. Tenant shall pay Landlord rent for use of the Premises in the amount of:

a) Three-Thousand Five-Hundred Seventy-Five and 00/100 Dollars (\$3,575.00) per month for the period beginning on the Date of Occupancy and ending on December 31, 2014 with this amount being pro-rated on a per diem basis in the event that the Date of Occupancy is not the first day of a month.

b) Three-Thousand Six-Hundred Forty-Five and 00/100 Dollars (\$3,645.00) per month for the period beginning on January 1, 2015 and ending on December 31, 2015.

c) Three-Thousand Seven-Hundred Fifteen and 00/100 Dollars (\$3,715.00) per month for the period beginning on January 1, 2016 and ending on December 31, 2016.

d) Three-Thousand Seven-Hundred Eighty-Five and 00/100 Dollars (\$3,785.00) per month for the period beginning on January 1, 2017 and ending on December 31, 2017.

e) Three-Thousand Eight-Hundred Fifty-Five and 00/100 Dollars (\$3,855.00) per month for the period beginning on January 1, 2018 and ending on December 31, 2018.

f) Three-Thousand Nine-Hundred Thirty and 00/100 Dollars (\$3,930.00) per month for the period beginning on January 1, 2019 and ending on December 31, 2019.

g) Four-Thousand Five and 00/100 Dollars (\$4,005.00) per month for the period beginning on January 1, 2020 and ending on December 31, 2020.

h) Four-Thousand Eighty and 00/100 Dollars (\$4,080.00) per month for the period beginning on January 1, 2021 and ending on December 31, 2021.

Rent shall be paid by Tenant to Landlord at Westside Holistic Family Services, Inc., 4909 West Division Street, Chicago, Illinois 60651, or at such place as Landlord may from time to time hereby designate in writing to Tenant.

3.2 <u>Taxes and Other Levies</u>. Landlord shall pay when due all real estate taxes, duties, assessments, heat, gas, electricity for air-conditioning and lighting, sewer, water charges, and other levies assessed against the Premises, except for those charges which this Lease specifies that Tenant shall pay.

3.3 <u>Utilities</u>. Tenant shall pay when due all charges for electricity as metered for outlets only within the Premises. Tenant shall pay when due all telephone, internet, or other communication services supplied into the Premises for Tenant's use.

SECTION 4. <u>CONDITION AND ENJOYMENT OF PREMISES, ALTERATIONS AND</u> <u>ADDITIONS, SURRENDER</u>

4.1 <u>Condition of Premises Upon Delivery of Possession</u>. Landlord covenants that the Premises shall on the Date of Occupancy:

(a) Comply in all respects with all laws, ordinances, orders, rules, regulations, and requirements of all federal, state, and municipal governmental departments, ("Laws") which may by applicable to the Premises or to any portion thereof or to the use or manner of use of the Premises;

(b) Contain no environmentally hazardous materials.

Landlord's duty under this Section of the Lease shall survive Tenant's acceptance of the Premises.

4.2 <u>Covenant of Quiet Enjoyment</u>. Landlord covenants and agrees that Tenant, upon paying the rent and upon observing and keeping the covenants, agreements and conditions of this Lease on its part to be kept, observed, and performed, shall lawfully and quietly hold, occupy and enjoy the Premises (subject to the provisions of this Lease) during the Term without hindrance or molestation by Landlord or by any person or persons claiming under Landlord.

4.3 Landlord's Duty to Maintain Premises, Right of Access, Tenant's Self-Help. Unless otherwise provided in this Lease, Landlord shall, at Landlord's expense, keep the Premises in a condition of thorough repair and good order, and in compliance with all applicable provisions of the Municipal Code of the City of Chicago, including but not limited to those provisions in Title 13 ("Building and Construction"), Title 14 ("Electrical Equipment and Installation"), and Title 15 ("Fire Prevention"). If Landlord shall refuse or neglect to make needed repairs within thirty (30) days after receipt of written notice thereof sent by Tenant (unless such repair cannot be remedied within thirty (30) days, and Landlord shall have commenced and is diligently pursuing all necessary action to remedy such repair), Tenant is authorized to make such repairs and to deduct the cost thereof from rents accruing under this Lease. Landlord shall have the right of access to the Premises for the purpose of inspecting and making repairs to the Premises. Except in the case of emergencies, Landlord shall first give Tenant five (5) days' notice of Landlord's desire to enter the Premises and Landlord will schedule its entry so as to minimize any interference with Tenant's use of Premises.

4.4 <u>Use of the Premises</u>. Tenant shall not use the Premises in a manner that would violate any Laws. Tenant shall use and occupy the Premises for health services and/or other municipal services if appropriate as determined by Tenant. Tenant further covenants to comply in all respects with the Laws which may be applicable to the Premises or to the use or manner of use of the Premises. Tenant shall not disfigure or injure any improvement, fixtures, and equipment on the Premises.

4.5 <u>Alterations and Additions</u>. Tenant shall have the right to make any alterations, additions, and improvements on the Premises as it shall deem necessary. Any such alterations, additions, and improvements shall be in full compliance with the applicable Laws and Tenant must obtain the prior written consent of Landlord. Landlord shall not unreasonably withhold, delay, or condition such consent.

SECTION 5. ASSIGNMENT, SUBLEASE, AND LIENS

5.1 <u>Assignment and Sublease</u>. Tenant shall not assign this Lease in whole or in part, or sublet the Premises or any part thereof without the written consent of Landlord in each instance. Landlord shall not unreasonably withhold, delay, or condition such consent.

5.2 <u>Tenant's Covenant Against Liens</u>. Tenant shall not cause or permit any lien or encumbrance, whether created by act of Tenant, operation of law or otherwise, to attach to or be

placed upon Landlord's title or interest in the Premises. All liens and encumbrances created by Tenant shall attach to Tenant's interest only.

SECTION 6. INSURANCE AND INDEMNIFICATION

6.1 <u>Insurance</u>. Landlord shall procure and maintain at all times, at Landlord's own expense, during the Term of this Lease, the insurance coverages and requirements specified below, insuring all operations related to the Lease.

The kinds and amounts of insurance required are as follows:

(a) <u>Workers Compensation and Occupational Disease Insurance.</u> Workers Compensation and Employers Liability Insurance, in accordance with the laws of the State of Illinois, or any other applicable jurisdiction, covering all of Landlord's employees and Employer's Liability coverage with limits of not less than <u>\$100,000</u> each accident or illness.

(b) <u>Commercial Liability Insurance.</u> (Primary and Umbrella.) Commercial Liability Insurance or equivalent with limits of not less than \$1.000,000 per occurrence, for bodily injury, personal injury, and property damage liability. Coverage extensions shall include the following: All premises and operations, products/completed operations, defense, separation of insureds, and contractual liability (with <u>no</u> limitation endorsement). The City of Chicago, its employees, elected officials, agents, and representatives are to be named as additional insureds on a primary, non-contributory basis for any liability arising directly or indirectly from the Lease.

(c) <u>Automobile Liability Insurance.</u> (Primary and Umbrella.) When any motor vehicles (owned, non-owned and hired) are used in connection with work to be performed, the Landlord shall provide Comprehensive Automobile Liability Insurance with limits of not less than <u>\$1,000,000</u> per occurrence, for bodily injury and property damage.

(d) <u>All Risk Property Insurance</u>. All risk property insurance coverage shall be maintained by the Landlord for full replacement value to protect against loss, damage to or destruction of property.

Landlord shall be responsible for all loss or damage to personal property (including but not limited to materials, equipment, tools and supplies), owned or rented, by the Landlord.

6.2 <u>Other Terms of Insurance.</u> The Landlord will furnish the City of Chicago, Department of Fleet and Facility Management, Office of Real Estate Management, 30 North LaSalle Street, Room 300, Chicago, Illinois 60602, original Certificates of Insurance evidencing the required coverage to be in force on the date of this Lease, and Renewal Certificates of Insurance, or such similar evidence, if the coverages have an expiration or renewal date occurring during the term of this Lease. The receipt of any certificates does not constitute agreement by the City that the insurance requirements required by the Lease have been fully met or that the insurance policies indicated on the certificate are in compliance with all Lease requirements. The failure of the City to obtain certificates or other insurance evidence from Landlord shall not be deemed to be a waiver by the City. The Landlord shall advise all insurers

of the Lease provisions regarding insurance. Non-conforming insurance shall not relieve Landlord of its obligation to provide insurance as specified herein. Nonfulfillment of the insurance conditions may constitute a violation of the Lease, and the City retains the right to terminate the Lease until proper evidence of insurance is provided.

The insurance shall provide for 60 days prior written notice to be given to the City in the event coverage is substantially changed, canceled, or not renewed.

Any and all deductibles or self-insured retentions on referenced insurance coverages shall be borne by Landlord.

The Landlord agrees that insurers shall waive their rights of subrogation against the City of Chicago, its employees, elected officials, agents or representatives.

The Landlord expressly understands and agrees that any coverages and limits furnished by Landlord shall in no way limit the Landlord's liabilities and responsibilities specified within the Lease documents or by law.

The Landlord expressly understands and agrees that any insurance or self-insurance programs maintained by the City of Chicago shall apply in excess of and not contribute with insurance provided by the Landlord under the Lease.

The required insurance shall not be limited by any limitations expressed in the indemnification language herein or any limitation placed on the indemnity therein given as a matter of law.

The City of Chicago, Department of Finance, Office of Risk Management maintains the right to modify, delete, alter or change these requirements.

6.3 <u>Landlord's Indemnification</u>. Landlord shall indemnify and hold Tenant harmless against all liabilities, judgment costs, damages, and expenses which may accrue against, be charged to, or be recovered from Tenant by reason of Landlord's actions or negligent performance of or failure to perform any of its obligations under this Lease.

SECTION 7. DAMAGE OR DESTRUCTION

7.1 <u>Damage or Destruction</u>. If the Premises or the Building are damaged or destroyed by fire or other casualty to such an extent that Tenant cannot continue, occupy or conduct its normal business therein, or if, in Tenant's opinion, the Premises are rendered untenantable, Tenant shall have the option to declare this Lease terminated as of the date of such damage or destruction by giving Landlord written notice to such effect. If Tenant exercises this option to terminate, the rent shall be apportioned as of the date of such damage or destruction and Landlord shall forthwith repay to Tenant all prepaid rent within thirty (30) days of receipt of Tenant's written notice. If there is a casualty event, and Tenant's normal business operations are interrupted, but Tenant elects not to terminate the Lease under this section, the rent shall abate during the period that the Premises are not usable by Tenant.

SECTION 8. CONFLICT OF INTEREST AND GOVERNMENTAL ETHICS

8.1 <u>Conflict of Interest</u>. No official or employee of the City of Chicago, nor any member of any board, commission or agency of the City of Chicago, shall have any financial interest (as defined in Chapter 2-156 of the Municipal Code), either direct or indirect, in the Premises. Nor shall any such official, employee, or member participate in making or in any way attempt to use his or her position to influence any City governmental decision or action with respect to this Lease.

8.2 Duty to Comply with Governmental Ethics Ordinance. Landlord and Tenant Shall comply with Chapter 2-156 of the Municipal Code of Chicago, "Governmental Ethics," including but not limited to section 2-156-120, which states that no payment, gratuity, or offer of employment shall be made in connection with any City of Chicago contract as an inducement for the award of that contract or order. Any contract negotiated, entered into, or performed in violation of any of the provisions of Chapter 2-156 shall be voidable as to the City of Chicago.

SECTION 9. HOLDING OVER

9.1 <u>Holding Over</u>. Any holding over by Tenant shall be construed to be a tenancy from month to month only beginning on January 1, 2022 (the "**Holding Over**"). During the Holding Over the rent shall be at the same rate as set forth in Section 3.1 (h) of this Lease.

SECTION 10. MISCELLANEOUS

10.1 <u>Notice</u>. All notices, demands and requests which may be or are required to be given demanded or requested by either party to the other shall be in writing. All notices, demands and requests by Landlord to Tenant shall be delivered by national overnight courier or shall be sent by United States registered or certified mail, return receipt requested, postage prepaid addressed to Tenant as follows:

or at such other place as Tenant may from time to time designate by written notice to Landlord and to Tenant at the Premises. All notices, demands, and requests by Tenant to Landlord shall be delivered by a national overnight courier or shall be sent by United States registered or certified mail, return receipt requested, postage prepaid, addressed to Landlord as follows:

or at such other place as Landlord may from time to time designate by written notice to Tenant. Any notice, demand or request which shall be served upon Landlord by Tenant, or upon Tenant by Landlord, in the manner aforesaid, shall be deemed to be sufficiently served or given for all purposes hereunder at the time such notice, demand or request shall be mailed.

10.2 <u>Partial Invalidity</u>. If any covenant, condition, provision, term or agreement of this Lease shall, to any extent, be held invalid or unenforceable, the remaining covenants, conditions, provisions, terms and agreements of this Lease shall not be affected thereby, but each covenant, condition, provision, term or agreement of this Lease shall be valid and in force to the fullest extent permitted by law.

10.3 <u>Governing Law</u>. This Lease shall be construed and be enforceable in accordance with the laws of Illinois.

10.4 <u>Entire Agreement</u>. All preliminary and contemporaneous negotiations are merged into and incorporated in this Lease. This Lease contains the entire agreement between the parties and shall not be modified or amended in any manner except by an instrument in writing executed by the parties hereto.

10.5 <u>Captions and Section Numbers</u>. The captions and section numbers appearing in this Lease are inserted only as a matter of convenience and in no way define, limit, construe or describe the scope or intent of such sections of this Lease nor in any way affect this Lease.

10.6 <u>Binding Effect of Lease</u>. The covenants, agreements, and obligations contained in this Lease shall extend to, bind, and inure to the benefit of the parties hereto and their legal representatives, heirs, successors, and assigns.

10.7 <u>Time is of the Essence</u>. Time is of the essence of this Lease and of each and every provision hereof.

10.8 <u>No Principal/Agent or Partnership Relationship</u>. Nothing contained in this Lease shall be deemed or construed by the parties hereto nor by any third party as creating the relationship of principal and agent or of partnership or of joint venture between the parties hereto.

10.9 <u>Authorization to Execute Lease</u>. The parties executing this Lease hereby represent and warrant that they are the duly authorized and acting representatives of Landlord and Tenant respectively and that by their execution of this Lease, it became the binding obligation of Landlord and Tenant respectively, subject to no contingencies or conditions except as specifically provided herein.

10.10 <u>Termination of Lease</u>. Tenant shall have the right to terminate this Lease any time on or after January 1, 2015. Tenant must provide Landlord with sixty (60) days prior written notice.

10.11 <u>Force Majeure</u>. When a period of time is provided in this Lease for either party to do or perform any act or thing, the party shall not be liable or responsible for any delays due to strikes, lockouts, casualties, acts of God, wars, governmental regulation or control, and other causes beyond the reasonable control of the party, and in any such event the time period shall be extended for the amount of time the party is so delayed.

10.12 <u>Condemnation</u>. If the whole or any substantial part of the Premises are taken or condemned by any competent authority for any public use or purpose, or if any adjacent property or street shall be so condemned or improved in such a manner as to require the use of any part of the Premises, the term of this Lease shall, at the option of Landlord or the condemning authority, be terminated upon, and not before, the date when possession of the part so taken shall be required for such use or purpose, and Landlord shall be entitled to receive the entire award without apportionment with Tenant. Rent shall be apportioned as of the date of Tenant's vacating as the result of said termination.

10.13 <u>Federal Funding Restrictions</u>. It is mutually agreed and understood by and between the parties hereto that the rents payable under this Lease are derived in part from funds made available from the federal government. As a result, if Tenant defaults in the payment of any sums required to be paid under this Lease because of lack of federal funding, the sole remedy of the Landlord shall be for possession of the demised Premises within sixty (60) days from written notice from Landlord to Tenant of such failure to pay rent.

10.14 <u>No Broker</u>. The Department of Fleet and Facility Management does not use brokers, tenant representatives, or other finders. Tenant warrants to Landlord that no broker or finder (a) introduced Tenant to the Premises, (b) assisted Tenant in the negotiation of this Lease, or (c) dealt with Tenant on Tenant's behalf in connection with the Premises or this Lease. Landlord warrants to Tenant that no broker or finder (a) introduced Landlord to Tenant, (b) assisted Landlord in the negotiation of this Lease, or (c) dealt with Landlord on Landlord's behalf in connection with the Premises or this Lease. Under no circumstances shall Tenant make any payments due hereunder to any broker(s).

10.15 <u>Access to North Lot</u>. Landlord is the owner of the parking lot located at 4910 West Division Street (the "North Lot"). Landlord shall provide Tenant with non-exclusive access to the North Lot on a first-come first-served basis. Tenant shall comply with any parking rules and regulations in place on the Effective Date or thereafter promulgated in writing by Landlord with respect to Tenant's use of the North Lot.

10.16 <u>Restroom Access</u>. Tenant shall have non-exclusive access to the common area restrooms located on the fourth floor of the Building for use by Tenant's staff, clients, agents, and invitees.

10.17 <u>Community Room Access</u>. Tenant shall have non-exclusive access to the community room (the "**Community Room**") located on the 6^{th} floor of the Building for use by Tenant's staff. Tenant shall schedule access to the Community Room through Landlord. Tenant shall abide by all rules applicable to use of the Community Room.

10.18 <u>Amendments</u>. From time to time, the parties hereto may amend this Lease with respect to any provisions reasonably related to Tenant's use of the Premises (including, but not

limited to, leasehold expansion or relocation) and/or Landlord's administration of this Lease. Such amendment(s) shall not serve to extend the Term hereof nor serve to otherwise materially alter the essential provisions contained herein. Such amendment(s) shall be in writing, shall establish the factual background necessitating such alteration, shall set forth the terms and conditions of such modification, and shall be duly executed by both Landlord and Tenant. Such amendment(s) shall only take effect upon execution by both parties. Upon execution, such amendment(s) shall become a part of this Lease and all other provisions of this Lease shall otherwise remain in full force and effect.

SECTION 11. ADDITIONAL RESPONSIBILITIES OF LANDLORD

11.1 <u>Leasehold Improvements. Completion Notice, Acceptance, Date of Occupancy</u>. Landlord shall complete the following improvements to the Premises (the "Leasehold Improvements") within sixty (60) days of the Effective Date:

- a) Installation of plumbing and plumbing fixtures for lab rooms.
- b) Installation of plumbing and plumbing fixtures for exam rooms.
- c) Removal of non-loading bearing wall between registration areas and waiting areas.
- d) Replacement of existing carpeting with carpet tiles or floor tiles as selected by Tenant's Department of Public Health.
- e) Painting of all rooms as selected by Tenant's Department of Public Health.

Tenant's responsibility for reimbursement of the costs of the Leasehold Improvements shall not exceed Nine-Thousand and 00/100 Dollars (\$9,000.00). Upon Landlord's completion of the Leasehold Improvements, Landlord shall deliver to Tenant a written notification of such completion including an itemized list of the costs of the Leasehold Improvements (the "**Completion Notice**"). Within ten (10) days of receipt of the Completion Notice, Tenant shall provide Landlord with written determination regarding Tenant's acceptance of the condition of the Leasehold Improvements (the "**Acceptance**"). Tenant shall not unreasonably withhold, delay, or condition the Acceptance. If Tenant does not accept the Leasehold Improvements, Tenant shall provide Landlord with written notice specifying Tenant's objections. Tenant's date of occupancy and Tenant's commencement of rental payment obligations (the "**Date of Occupancy**") shall begin on the earlier of the date that Tenant begins to move into the Premises or thirty (30) days from the Acceptance. Tenant shall reimburse Landlord the costs of the Leasehold Improvements as detailed in the Completion Notice (unless Tenant takes written exception to any costs) within sixty (60) days from the Date of Occupancy.

11.2 <u>Custodial Services</u>. Landlord shall provide and pay for nightly custodial services for the Premises which shall be construed as cleaning, washing, emptying wastepaper baskets, replacement of light bulbs, sweeping and moving of furniture for cleaning purposes only.

11.3 <u>Water Service</u>. Landlord shall provide and pay for water service for the Premises.

11.4 <u>Plumbing</u>. Landlord shall maintain plumbing within the Premises in good and operable condition.

11.5 <u>Fire Extinguishers</u>. Landlord shall provide and maintain the required fire extinguishers on the Premises at all times. Landlord will not be responsible for fire extinguishers vandalized or stolen by Tenant's staff, clients, agents, or invitees.

11.6 <u>Maintenance</u>. Landlord shall provide engineering service for maintenance of the exterior and interior of the Premises, including the elevators and all structural, mechanical and electrical components. Engineering service shall refer strictly to service for the maintenance of the physical plant.

11.7 <u>Air Conditioning</u>. Landlord shall provide and pay for air-conditioning to the Premises whenever air-conditioning shall be necessary and/or required for the comfortable occupancy of the Premises. Landlord shall maintain the plant and equipment in good and operable condition, excluding damage caused by acts of vandalism by Tenant's staff, agents, or invitees

11.8 <u>Heat</u>. Landlord shall provide and pay for heat to the Premises whenever heat shall be necessary and/or required for the comfortable occupancy of the Premises. Landlord shall maintain the plant and equipment in good operable condition, excluding damage caused by acts of vandalism by Tenant's staff, agents, or invitees.

11.9 <u>Smoke Detectors</u>. Landlord shall provide and maintain smoke detectors for the Premises. Landlord will not be responsible for smoke detectors vandalized or stolen by Tenant's staff, agents, or invitees.

11.10 <u>Pest Control</u>. Landlord shall provide and pay for pest control services for the Premises whenever reasonably necessary. Notwithstanding the foregoing, Landlord shall not be responsible for such pest control services where Tenant is negligent with respect to maintaining reasonable sanitary standards within the Premises

11.11 <u>Snow Removal</u>. Landlord shall provide and pay for prompt removal of snow and ice from the North Lot and the sidewalks which immediately abut the Premises.

11.12 <u>Window Washing</u>. Landlord shall provide and pay for exterior window washing on a reasonable basis.

11.13 <u>Unauthorized Improvements</u>. Any improvements to the Premises effectuated by Landlord on Tenant's behalf can only be performed upon written approval and concurrent Notice to Proceed from the Commissioner of the Department of Fleet and Facility Management. Approval from any other department(s), other employee(s), or anyone acting, or claiming to act, on Tenant's behalf shall be deemed invalid and of no force or effect.

11.14 <u>Economic Disclosure Statement Affidavit Updates</u>. Throughout the Term (and during any Holding Over), Landlord shall provide Tenant with any material updates to the information previously submitted in Landlord's Economic Disclosure Statement Affidavit. Tenant may also request such updates from time to time. Tenant reserves the right to withhold rental payment under this Lease in the event Landlord fails to provide such updates.

SECTION 12. ADDITIONAL RESPONSIBILITIES OF TENANT

12.1 <u>Broken Plate Glass</u>. Tenant shall replace any broken plate glass in Premises during term of Lease which is not caused by Landlord's negligence.

12.2 <u>Tenant Signage</u>. Tenant reserves the right to install an appropriate sign on the front exterior of the Premises provided that such signage complies with any applicable Laws.

12.3 <u>Condition of Premises at Lease Termination</u>. Upon the termination of this Lease, Tenant shall surrender the Premises to Landlord in a comparable condition to the condition of the Premises at the Effective Date, with normal wear and tear taken into consideration.

12.4 <u>Landlord Signage</u>. Tenant will allow Landlord to place upon Premises notices of rental signs not to exceed 2' x 2' in size at the end of the Term.

12.5 <u>Security Alarm Service</u>. Tenant shall be responsible for security within the Premises. Tenant acknowledges that Landlord shall not provide any security services. Tenant shall pay for monthly alarm service, if such services are necessary in Tenant's opinion.

12.6 <u>Illegal Activity</u>. Tenant, or any of its staff, clients, agents, or invitees, shall not perform or permit any practice that is injurious to the Premises or the Building, unreasonably disturbs other Tenants within the Building, is illegal, or increases the rate of insurance on the Premises or the Building.

12.7 <u>Hazardous Materials</u>. Tenant shall keep out of the Premises materials which cause a fire hazard or safety hazard and comply with reasonable requirements of Landlord's fire insurance carrier. Tenant shall be responsible for appropriate removal and disposal of any medical wastes generated or used within the Premises.

12.8 <u>Repairs for Tenant Negligence, Vandalism, or Misuse</u>. Tenant shall not destroy, deface, damage, impair, nor remove any part of the Premises or the Building, equipment, or appurtenances. Tenant shall assume all responsibility for any repairs to the Premises or the Building necessitated by the negligence, vandalism, or intentional misuse therein by Tenant's staff, clients, agents, or invitees. Landlord shall notify Tenant in writing of such damage. Tenant may perform such repairs with Tenant's service providers at Tenant's sole cost without further setoff or deduction. In the alternative, Tenant may direct Landlord in writing to perform said repairs subject to full reimbursement to Landlord by Tenant of all costs associated with such repairs excluding any overhead and/or profit. Any repairs to the Premises effectuated by Landlord under this section shall only be performed by Landlord upon written approval from the Commissioner of the Department of Fleet and Facility Management. Repairs made without said written approval and concurrent Notice to Proceed from the Commissioner of the Department of Fleet and Facility Management of the Department of Fleet and Facility Management shall not be reimbursable.

12.9 <u>Compliance with Rules</u>. Tenant shall comply with all reasonable building rules and regulations in place on the Effective Date or thereafter promulgated in writing by Landlord.

12.10 <u>Vending Machines</u>. Tenant reserves the right to place vending machines within the Premises and derive revenue therefrom. Tenant, or Tenant's contractor, shall maintain such vending machines in accordance with all applicable Laws.

12.11 <u>Biometrics Machine</u>. Tenant shall be responsible for the maintenance of any biometrics machine or other employee tracking devices that the Tenant may elect to install within the Premises.

SECTION 13. LANDLORD DISCLOSURES AND AFFIRMATIONS

13.1 Business Relationships. Landlord acknowledges (a) receipt of a copy of Section 2-156-030 (b) of the Municipal Code of Chicago, (b) that it has read such provision and understands that pursuant to such Section 2-156-030 (b) it is illegal for any elected official of the City, or any person acting at the direction of such official, to contact, either orally or in writing, any other the City official or employee with respect to any matter involving any person with whom the elected City official or employee has a "Business Relationship" (as defined in Section 2-156-080 of the Municipal Code of Chicago), or to participate in any discussion in any City Council committee hearing or in any City Council meeting or to vote on any matter involving the person with whom an elected official has a Business Relationship, and (c) notwithstanding anything to the contrary contained in this Lease, that a violation of Section 2-156-030 (b) by an elected official, or any person acting at the direction of such official, with respect to any transaction contemplated by this Lease shall be grounds for termination of this Lease and the transactions contemplated hereby. Landlord hereby represents and warrants that no violation of Section 2-145-030 (b) has occurred with respect to this Lease or the transactions contemplated hereby.

13.2 Patriot Act Certification. Landlord represents and warrants that neither Landlord nor any Affiliate (as hereafter defined) thereof is listed on any of the following lists maintained by the Office of Foreign Assets Control of the U.S. Department of the Treasury, the Bureau of Industry and Security of the U.S. Department of Commerce or their successors, or on any other list of persons or entities with which the City may not do business under any applicable Laws: the Specially Designated Nationals List, the Denied Persons List, the Unverified List, the Entity List and the Debarred List. As used in this Section, an "Affiliate" shall be deemed to be a person or entity related to Landlord that, directly or indirectly, through one or more intermediaries, controls, is controlled by another person or entity, if controlled in any manner whatsoever that results in control in fact by that other person or entity is acting jointly or in concert), whether directly or indirectly and whether through share ownership, a trust, a contract or otherwise.

13.3 Prohibition on Certain Contributions-Mayoral Executive Order No. 2011-4. Landlord agrees that Landlord, any person or entity who directly or indirectly has an ownership or beneficial interest in Landlord of more than 7.5 percent ("<u>Owners</u>"), spouses and domestic partners of such Owners, Landlord's contractors (i.e., any person or entity in direct contractual privity with Landlord regarding the subject matter of this Lease) ("<u>Contractors</u>"), any person or entity who directly or indirectly has an ownership or beneficial interest in any Contractor of more than 7.5 percent ("<u>Sub-owners</u>") and spouses and domestic partners of such Sub-owners (Landlord and all the other preceding classes of persons and entities are together the "<u>Identified Parties</u>"), shall not make a contribution of any amount to the Mayor of the City of Chicago (the "<u>Mayor</u>") or to his political fundraising committee (a) after execution of this Lease by Landlord, (b) while this Lease or any Other Contract, or (d) during any period while an extension of this

Lease or any Other Contract is being sought or negotiated. This provision shall not apply to contributions made prior to May 16, 2011, the effective date of Executive Order 2011-4.

Landlord represents and warrants that from the later of (a) May 16, 2011, or (b) the date the City approached Landlord, or the date Landlord approached the City, as applicable, regarding the formulation of this Lease, no Identified Parties have made a contribution of any amount to the Mayor or to his political fundraising committee.

Landlord agrees that it shall not: (a) coerce, compel or intimidate its employees to make a contribution of any amount to the Mayor or to the Mayor's political fundraising committee; (b) reimburse its employees for a contribution of any amount made to the Mayor or to the Mayor's political fundraising committee; or (c) bundle or solicit others to bundle contributions to the Mayor or to his political fundraising committee.

Landlord agrees that the Identified Parties must not engage in any conduct whatsoever designed to intentionally violate this provision or Mayoral Executive Order No. 2011-4 or to entice, direct or solicit others to intentionally violate this provision or Mayoral Executive Order No. 2011-4.

Notwithstanding anything to the contrary contained herein, Landlord agrees that a violation of, non-compliance with, misrepresentation with respect to, or breach of any covenant or warranty under this Lease or violation of Mayoral Executive Order No. 2011-4 constitutes a breach and default under this Lease, and under any Other Contract for which no opportunity to cure will be granted, unless the City, in its sole discretion, elects to grant such an opportunity to cure. Such breach and default entitles the City to all remedies (including, without limitation, termination for default) under this Lease, and under any Other Contract, at law and in equity. This provision amends any Other Contract and supersedes any inconsistent provision contained therein.

If Landlord intentionally violates this provision or Mayoral Executive Order No. 2011-4 prior to the Closing, the City may elect to decline to close the transaction contemplated by this Lease.

For purposes of this provision:

(a) "<u>Bundle</u>" means to collect contributions from more than one source, which contributions are then delivered by one person to the Mayor or to his political fundraising committee.

(b) "<u>Other Contract</u>" means any other agreement with the City to which Landlord is a party that is (i) formed under the authority of Chapter 2-92 of the Municipal Code of Chicago; (ii) entered into for the purchase or Lease of real or personal property; or (iii) for materials, supplies, equipment or services which are approved or authorized by the City Council.

(c) "<u>Contribution</u>" means a "political contribution" as defined in Chapter 2-156 of the Municipal Code of Chicago, as amended. (d) Individuals are "<u>domestic partners</u>" if they satisfy the following criteria:

(i) they are each other's sole domestic partner, responsible for each other's common welfare; and

(ii) neither party is married; and

(iii) the partners are not related by blood closer than would bar marriage in the State of Illinois; and

(iv) each partner is at least 18 years of age, and the partners are the same sex, and the partners reside at the same residence; and

- (v) two of the following four conditions exist for the partners:
 - (1) The partners have been residing together for at least 12 months.
 - (2) The partners have common or joint ownership of a residence.
 - (3) The partners have at least two of the following arrangements:
 - (A) joint ownership of a motor vehicle;
 - (B) joint credit account;
 - (C) a joint checking account;
 - (D) a Lease for a residence identifying both domestic partners as Landlords.
 - (4) Each partner identifies the other partner as a primary beneficiary in a will.

(e) "<u>Political fundraising committee</u>" means a "political fundraising committee" as defined in Chapter 2-156 of the Municipal Code of Chicago, as amended.

13.4 Waste Ordinance Provisions. In accordance with Section 11-4-1600(e) of the Municipal Code of Chicago, Landlord warrants and represents that it, and to the best of its knowledge, its contractors and subcontractors, have not violated and are not in violation of any provisions of Section 7-28 or Section 11-4 of the Municipal Code (the "Waste Sections"). During the period while this Lease is executory, Landlord's, any general contractor's or any subcontractor's violation of the Waste Sections, whether or not relating to the performance of this Lease, constitutes a breach of and an event of default under this Lease, for which the opportunity to cure, if curable, will be granted only at the sole designation of the Commissioner of the Department of Fleet and Facility Management. Such breach and default entitles the City to all remedies under the Lease, at law or in equity. This section does not limit Landlord's, general contractor's and its subcontractors' duty to comply with all applicable federal, state, county and municipal laws, statutes, ordinances and executive orders, in effect now or later, and whether or not they appear in this Lease. Non-compliance with these terms and conditions may be used by the City as grounds for the termination of this Lease, and may further affect the Landlord's eligibility for future contract awards.

13.5 <u>Failure to Maintain Eligibility to do Business with City</u>. Failure by Landlord or any controlling person (as defined in Section 1-23-010 of the Municipal Code of Chicago)

thereof to maintain eligibility to do business with the City of Chicago as required by Section 1-23-030 of the Municipal Code of Chicago shall be grounds for termination of this Lease and the transactions contemplated thereby. Landlord shall at all times comply with Section 2-154-020 of the Municipal Code of Chicago.

13.6 <u>Cooperation with Office of Inspector General and Legislative Inspector General</u>. It is the duty of Landlord and any bidder, proposer, contractor, subcontractor, and every applicant for certification of eligibility for a City contract or program, and all officers, directors, agents, partners, and employees of any such bidder, proposer, contractor, subcontractor or such applicant to cooperate with the Legislative Inspector General in any investigation or hearing undertaken pursuant to Chapter 2-55 of the Municipal Code, and to cooperate with the Inspector General in any investigation or hearing undertaken pursuant to Chapter 2-56 of the Municipal Code. Landlord represents and warrants that it understands and will abide by all provisions of Chapter 2-55 and Chapter 2-56 of the Municipal Code and that Landlord will inform its contractors and subcontractors of this provision and require their compliance.

13.7 2011 City Hiring Plan Prohibitions.

(i) The Tenant is subject to the June 24, 2011 "City of Chicago Hiring Plan" (the "2011 City Hiring Plan") entered in Shakman v. Democratic Organization of Cook County, Case No 69 C 2145 (United States District Court for the Northern District of Illinois). Among other things, the 2011 City Hiring Plan prohibits the Tenant from hiring persons as governmental employees in non-exempt positions on the basis of political reasons or factors.

(ii) Landlord is aware that Tenant policy prohibits Tenant employees from directing any individual to apply for a position with Landlord, either as an employee or as a subcontractor, and from directing Landlord to hire any individual as an employee or as a subcontractor. Accordingly, Landlord must follow its own hiring and contracting procedures, without being influenced by Tenant or Tenant employees. Any and all personnel provided by Landlord under this Lease are employees or subcontractors of Landlord, not employees of the City of Chicago. This Lease is not intended to and does not constitute, create, give rise to, or otherwise recognize an employer-employee relationship of any kind between the Tenant and any personnel provided by Landlord.

(iii) Landlord will not condition, base, or knowingly prejudice or affect any term or term or aspect to the employment of any personnel provided under this Lease, or offer employment to any individual to provide services under this Lease, based upon or because of any political reason or factor, including, without limitation, any individual's political affiliation, membership in a political organization or party, political support or activity, political financial contributions, promises of such political support, activity or financial contributions, or such individual's political sponsorship or recommendation. For purposes of this Lease, a political organization or party is an identifiable group or entity that has as its primary purpose the support of or opposition to candidates for elected public office. Individual political activities are the activities of individual persons in support of or in opposition to political organizations or parties or candidates for elected public office.

(iv) In the event of any communication to Landlord by a Tenant employee or Tenant official in violation of Section 13.7, or advocating a violation of Section 13.7, Landlord will, as

soon as is reasonably practicable, report such communication to the Hiring Oversight Section of the Tenant's Office of the Inspector General ("IGO Hiring Oversight"), and also to the head of the relevant Tenant department utilizing services provided under this Lease. Landlord will also cooperate with any inquiries by OIG Hiring Oversight.
