**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Single Family Residence District symbols and indications as shown on Map No. 1-H in the area bounded by

The public alley next north of and parallel to West Erie Street; a line 200 feet east of and parallel to North Wood Street; West Erie Street; a line 175 feet east of and parallel to North Wood Street

to those of a RM-4.5 Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
