ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2, Community Shopping District symbols and indications as shown on Map No. 9-G in area bound by

North Southport Avenue, a line 72.35 feet South of and parallel to West Byron Avenue, the alley next East of and parallel to North Southport Avenue, a line 97.35 feet South of and parallel to West Byron Avenue

to those of a B2-3 Neighborhood Mixed Use District.

SECTION 2. This ordinance takes effect after its passage and approval.


