ORDINANCE GRANDBAR Acct. No. 25371 - 1 Permit No. 1115039

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GRANDBAR, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1600 W. Grand Ave..

Said Awning(s) at W. Grand Avenue measure(s):

One (1) at seventeen point one seven (17.17) feet in length, and two (2) feet in width for a total of thirty-four point three four (34.34) square feet.

Said Awning(s) at N. Ashland Avenue measure(s):

One (1) at eleven point one seven (11.17) feet in length, and two (2) feet in width for a total of twenty-two point three four (22.34) square feet.

One (1) at fourteen (14) feet in length, and two (2) feet in width for a total of twenty-eight (28) square feet.

One (1) at twenty point seven five (20.75) feet in length, and two (2) feet in width for a total of forty-one point five (41.5) square feet.

One (1) at thirty-one point three three (31.33) feet in length, and two (2) feet in width for a total of sixty-two point six six (62.66) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1115039 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 12/12/2012.
