ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-3 Limited Manufacturing/Business Park

District symbols and indications as shown on Map No.6-E in the area bounded by

a line 200.26 feet north of and parallel to East 26th Street; South Wabash Avenue; a line 100.13 feet north of and parallel to East 26th Street; and a line 180.68 feet west of and parallel to South Wabash Avenue,

to those of a C1-5 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

ZONING MATRIX / ANALYSIS

<u>Project Description:</u> The Applicant proposes to renovate the existing building located at 2540 S. Wabash so that it can be used as a retail bike and repair shop. The existing building has a building footprint of approximately 27,428 square feet. It is currently a vacant, warehouse building. The Applicant seeks to rezone the property to allow the interior renovation of this building for a retail use. Specifically, Kozy Cyclery will sell bicycles, bicycle parks and accessories as well as perform repairs on bikes. There will be approximately 8-13 employees, depending on the season. The Applicant hopes to commence construction as soon as the entitlement process is complete.
