Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PEET'S COFFEE & TEA, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use five (5) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1328 S. Halsted St..

Said Awning(s) at N HALSTED ST measure(s):

One (1) at six (6) feet in length, and two (2) feet in width for a total of twelve (12) square feet.

Two (2) at eight point three three (8.33) feet in length, and two (2) feet in width for a total of thirty-three point three two (33.32) square feet.

One (1) at thirteen point three three (13.33) feet in length, and two (2) feet in width for a total of twenty-six point six six (26.66) square feet.

Said Awning(s) at MAXWELL ST measure(s):

One (1) at thirteen point three three (13.33) feet in length, and two (2) feet in width for a total of twenty-six point six six (26.66) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1113995 herein granted the sum of seventy-five (\$75.00) per annum in advance.


A 25% penalty will be added for payments received after due date.


