ORDINANCE Vintage Charm, Inc. Acct. No. 392250 - 1 Permit No. 1115143

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Vintage Charm, Inc., upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Banner(s) projecting over the public right-of-way adjacent to its premises known as 1735 N. Damen Ave..

Said Banner(s) at N. Damen Avenue measure(s):

One (1) at two point five (2.5) feet in length, and four point zero two (4.02) feet in width for a total of ten point zero five (10.05) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1115143 herein granted the sum of seventy-five (\$75.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.



#### Overall view of awning and banner



#### New Wall Banner:

(1) New double sided wall banner with 30" width x 48.25" height. The banner will be installed on the existing banner hardware. However the existing bottom bracket will be raised and positioned 4' higher than existing top bracket.

\* Text height of "V" is 4 inches and text height of "m" is 3 inches on banner. Logo on banner is 20 inches high x 18.75 inches wide.
