LOADING ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

WARD LOADING ZONES / STANDING ZONES:

- 3 2600 S. State Street; S. State Street (west side) from a point 50 feet south of W. 26th Street to a point 20 feet south thereof; No Parking Loading Zone, 7:00am to 12:00am, all days [O2014-9105]
- 3 98 E. Cermak Road; E. Cermak Road (south side) from a point 30 feet west of S. Michigan Avenue to a point 20 feet west thereof; 15 Minute Standing Zone, 6:00am to 6:00pm, Monday through Saturday [O2014-9108]
- 27 201-209 N. Green Street; N. Green Street (east side) from a point 20 feet north of W. Lake Street to a point 40 feet north thereof; No Parking Loading Zone, 6:00am to 3:00am, all days -- (14-01314362) [O2014-5061]

WARD AMEND LOADING ZONES / STANDING ZONES:

- 1 1450 W. Chicago Avenue; Amend Ordinance Passed 10/16/2013, journal page 61813, which reads: 1450 W. Chicago Avenue; No Parking Loading Zone, distance of 20 feet, 12:00pm to 2:00am, all days, by striking the above and inserting in lieu thereof:
 W. Chicago Avenue (north side) from a point 93 feet east of N. Greenview Avenue to a point 32 feet east thereof; No Parking Loading Zone, 9:00am to 1:00am, all days
 -- (14-00717629) [O2014-2546]
- W. Armitage Avenue; Amend Ordinance Passed 7/30/2014, journal page 85735, which reads: W. Armitage Avenue (south side) from a point 315 feet east of N. Racine Avenue to a point 25 feet east thereof; No Parking Loading Zone, distance of 25 feet, 5:00pm to 10:00pm, Monday through Friday, 11:00am to 10:00pm, Saturday, and 11:00am to 6:00pm, Sunday, by striking the above and inserting in lieu thereof: W. Armitage Avenue (south side) from a point 283 feet east of N. Racine Avenue to a point 32 feet east thereof; No Parking Loading Zone, distance of 32 feet, 5:00pm to 10:00pm, Monday through Friday, and 11:00am to 10:00pm, Saturday and Sunday [O2014-8914]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
