ORDINANCE

WHEREAS, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available for persons of low- and moderate-income; and

WHEREAS, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City;

WHEREAS, The Interfaith Housing Development Corporation of Chicago is an Illinois not-for-profit corporation and tax-exempt public charity whose mission is to develop, own and manage affordable rental housing for low and moderate income individuals and families ("IHDC");

WHEREAS, IHDC is the sole member of Jeffery Towers Apartments LLC, an Illinois limited liability company ("Existing Owner");

WHEREAS, Existing Owner owns that certain 7-story, residential apartment building containing approximately one hundred and thirty-five (135) residential dwelling units, common area and surface and garage parking spaces, located at 7020-7028 South Jeffery Boulevard in the City of Chicago that is commonly known as Jeffery Towers Apartments (the "Property");

WHEREAS, IHDC and Existing Owner have proposed a project to examine and make extensive repairs to the Property's exterior masonry walls, install a new fire safety system, plumbing system, boiler and heating system, electrical service, exterior ramp, interior ramp, laundry room and elevators, and otherwise rehabilitate and improve the Property so that it can serve as a source of quality, affordable rental housing for low and moderate-income individuals and families of the City of Chicago (the "Project"), and to the extent permitted to finance acquisition costs of the Property;

WHEREAS, in connection with the Project the Existing Owner intends to admit new investors as members of Jeffery Towers Apartments, LLC (as so reconstituted the "Borrower");

WHEREAS, IHDC and Existing Owner have requested that the City issue multi-family housing revenue bonds, notes or other indebtedness in an amount not to exceed Eleven Million Dollars (\$11,000,000) (the "Bonds") for the purpose of financing all or a portion of the Project costs, including but not limited to the costs incurred in connection with the issuance of the Bonds:

WHEREAS, it is intended that the interest on the Bonds will be excluded from gross income for federal income tax purposes; and

WHEREAS, it is intended that this ordinance shall constitute a declaration of intent to reimburse certain eligible expenditures for the Project made prior to the issuance of the Bonds from the proceeds of the Bonds (if and when issued) within the meaning of Section 1.150-2 of the Treasury Regulations promulgated under the Internal Revenue Code of 1986, as amended (the "Treasury Regulations"); now, therefore,

Be It Ordained by the City Council of the City of Chicago:

- **SECTION 1**. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.
- **SECTION 2**. The City intends to issue the Bonds and lend the proceeds thereof to Borrower, IHDC or an entity affiliated with or related to Borrower or IHDC, for the purpose of financing all or a portion of the Project costs, including but not limited to the costs incurred in connection with the issuance of the Bonds. The maximum principal amount of Bonds which the City intends to issue for the Project will not exceed Eleven Million Dollars (\$11,000,000).
- **SECTION 3**. Certain costs will be incurred by Borrower and IHDC, or an entity affiliated with or related to Borrower or IHDC, in connection with the Project prior to the issuance of Bonds. The City reasonably expects to reimburse such costs with proceeds of the Bonds.
- **SECTION 4**. The costs to be reimbursed will be paid from funds of Borrower, IHDC or an entity affiliated with or related to Borrower or IHDC, which have been allocated to other purposes.
- **SECTION 5**. This ordinance is consistent with the budgetary and financial circumstances of the City. No funds from sources other than the Bonds are or are reasonably expected to be, reserved, allocated on a long-term basis or otherwise set aside by the City for the Project costs to be paid from the proceeds of the Bonds.
- **SECTION 6.** This ordinance constitutes a declaration of official intent of the City with respect to the Project under Section 1.150-2 of the Treasury Regulations.
- **SECTION 7**. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.
- **SECTION 8**. This ordinance shall be effective as of the date of its passage and approval.
