<u>ORDINANCE</u>

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No.5-N in the area bounded by

a line 109.51 feet south of and parallel to West Bloomingdale Avenue; the alley next east of and parallel to North Harlem Avenue; a line 149.51 feet south of and parallel to West Bloomingdale Avenue; and North Harlem Avenue,

to those of a C1-2 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
