ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the PMD-2, Planned Manufacturing District 2, symbols and indications as shown on Map No. 5-G in the area bounded by

The public alley next north of and parallel to West North Avenue; a line 50.00 feet east of and parallel to the east line of Ada Street; a line 75.00 feet east of and parallel to the east line of Ada Street; and West North Avenue,

to those of a C3-1 Commercial, Manufacturing and Employment District.

SECTION 2. This ordinance takes effect after its passage and approval.




ZONING AND DEVELOPMENT ANALYSIS


The subject property, located at 1308 West North Avenue, in Chicago, Cook County, Illinois, is located on the north side of West North Avenue, approximately 350' east of North Elston Avenue. The parcel is bound by existing public alleys to the north and west. The east side of the parcel is bound by an adjoining building. The parcel is currently occupied by an existing one-story brick building approximately 3,125-SF in size.

Following is a summary of our zoning and development analysis for the above-referenced property:

- Lot Area = 3,125-SF

- Density (lot area per dwelling unit): not applicable. Site is not a residential development.
