ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-2, Light Industry District symbols shown on Map 1-G in the area generally bounded by:

the public alley next northeast of the line parallel to northerly retainer wall of the John F. Kennedy Expressway; the alley next north of West Hubbard Street; North Green Street; West Hubbard Street; a line parallel to the northerly retainer wall of

the John F. Kennedy Expressway; the alley next west of North Green Street

to the designation of B2-3, Neighborhood, Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and approval.

In compliance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about December 10, 2014, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of The Kachadurian Group, LLC, the Applicant, for the property commonly known as 440-46 North Green Street.
