
Applicant seeks a Type I Map Amendment of the City of Chicago Zoning Map from the current B3-1 District to that of a C1-5 District for the property commonly known as 4240 West Irving Park Road. The subject site measures approximately 133.34 feet in width by 156.48 feet in depth. This result in a total lot area of 20,865 square feet.

The subject consists of three legal lots that are improved with a church building. Applicant seeks to rehabilitate the existing building and use it as a brewery, bar and restaurant. The project will provide 39 parking spaces including 1 accessible space.


