ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C1-2, Neighborhood Commercial District symbols as shown on Map No. 3-F in the area bounded by:

A line 120.10 feet North of and parallel to West Oak Street; North Larrabee Street; a line 70 feet North of and parallel to West Oak Street (or the public alley next North of and parallel to West Oak Street); the public alley next West of and almost parallel to North Larrabee Street.

To those of a B2-3, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and approval.

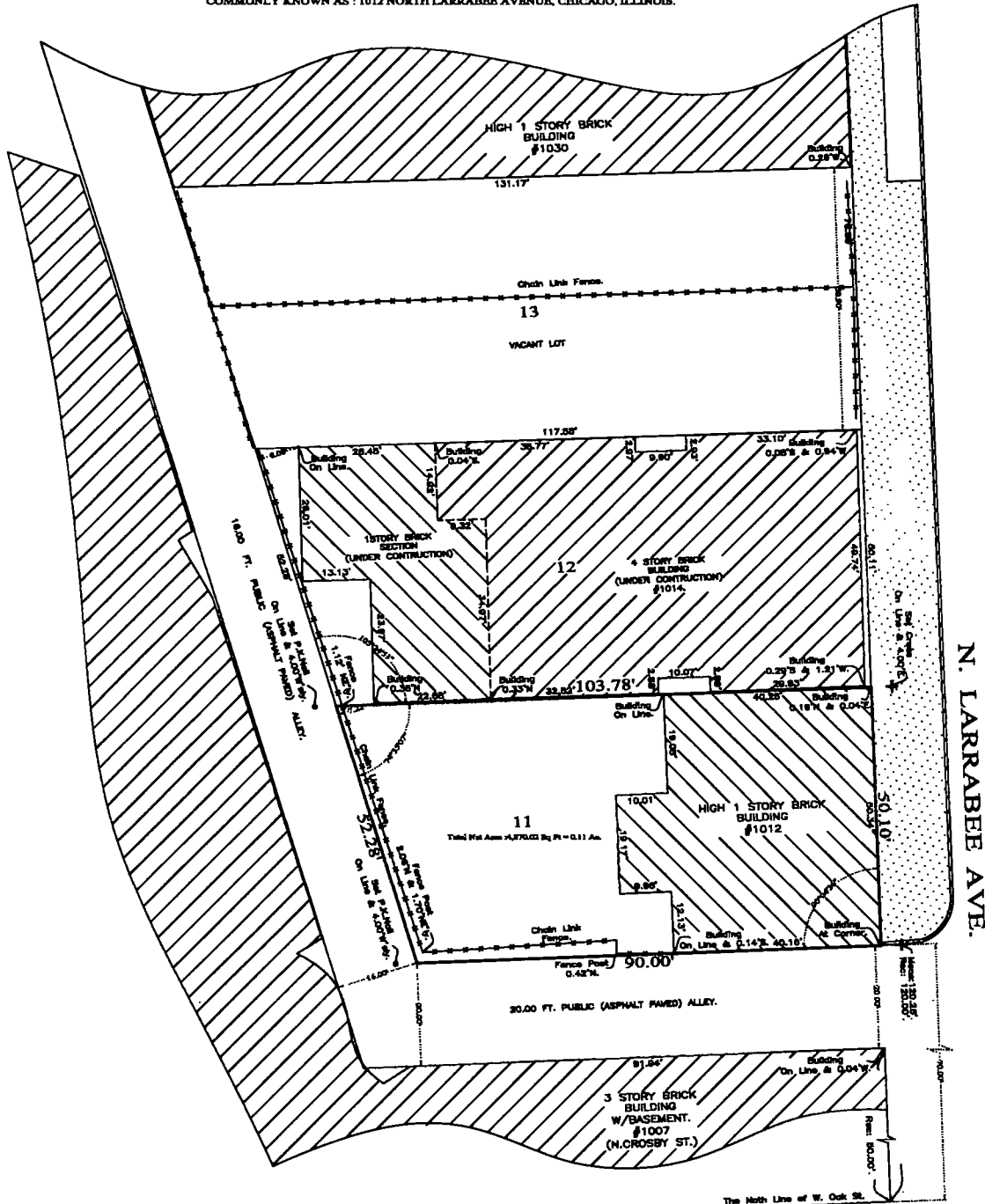



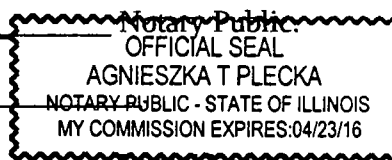
