ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the M1-3, Limited Manufacturing/Business Park District symbols as shown on Map No. 1-G in the area bounded by:

**The public alley next South-West of and almost parallel to North Milwaukee Avenue;
North Morgan Street; Kennedy Expressway Right of Way.**

To those of a B2-5, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and approval.

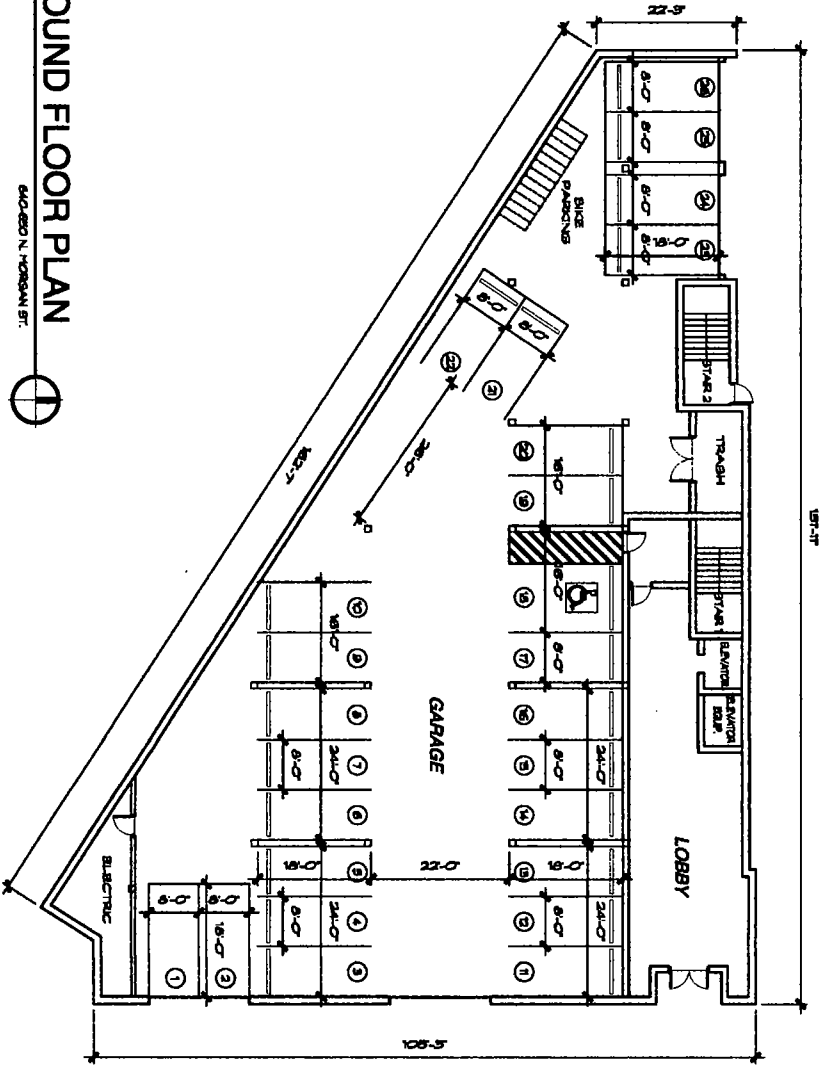

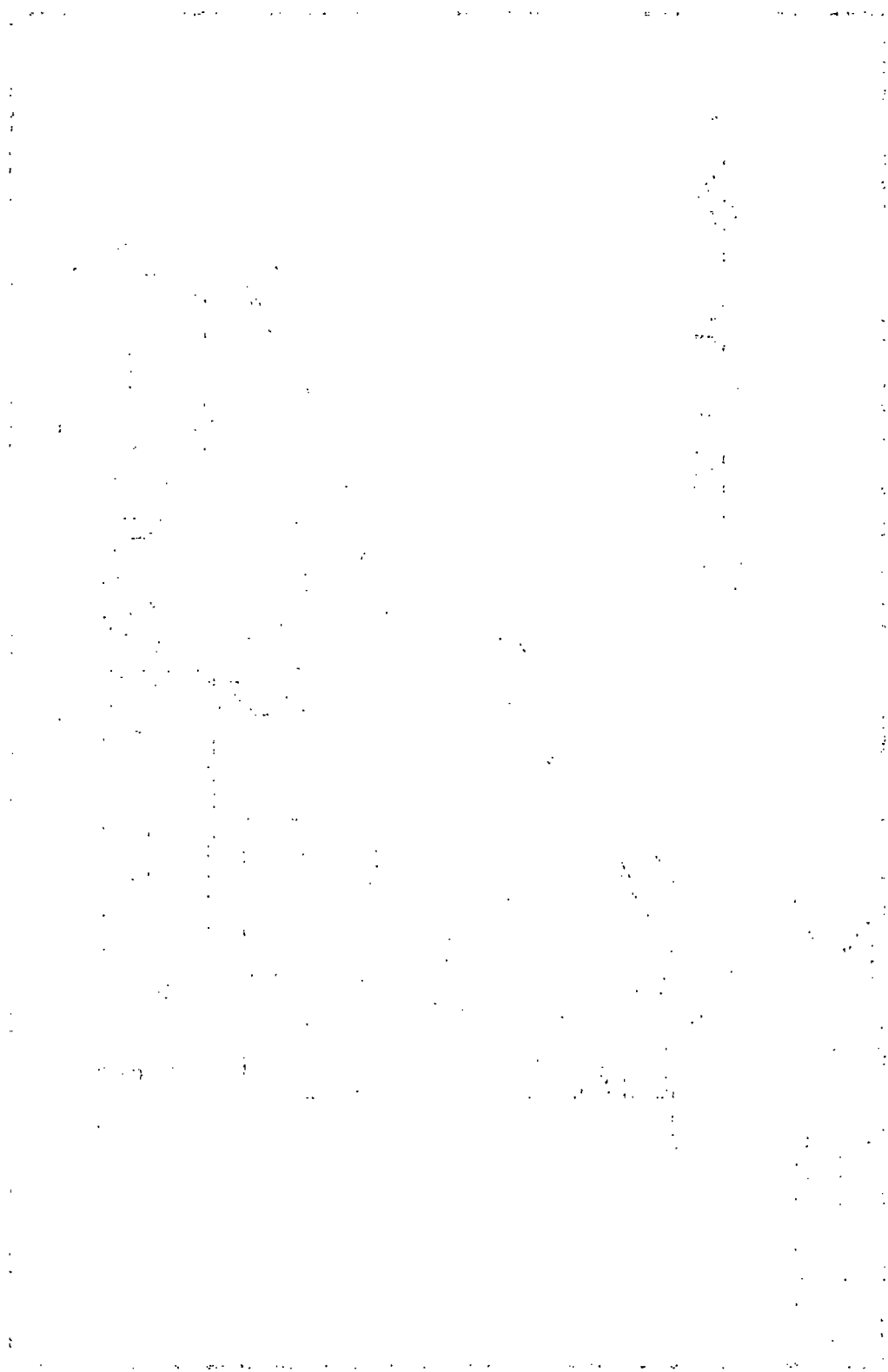

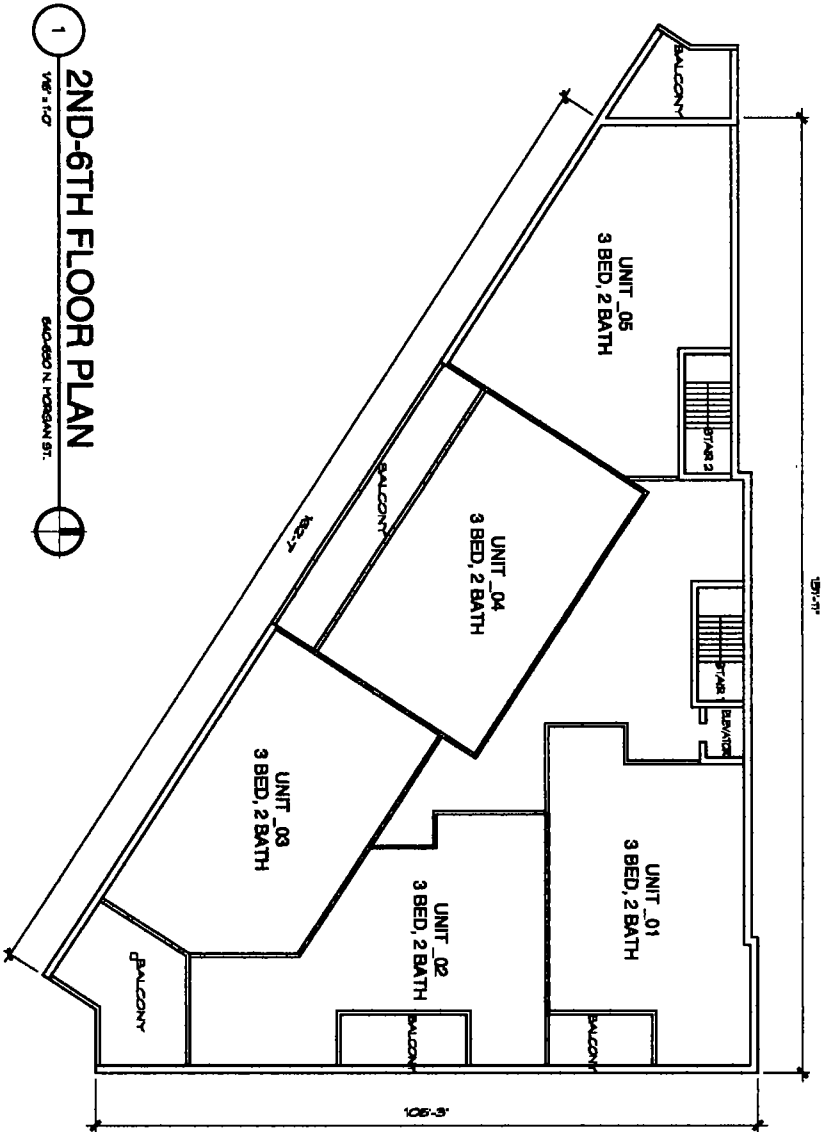
GROUND FLOOR PLAN

640-650 N. MORGAN ST.

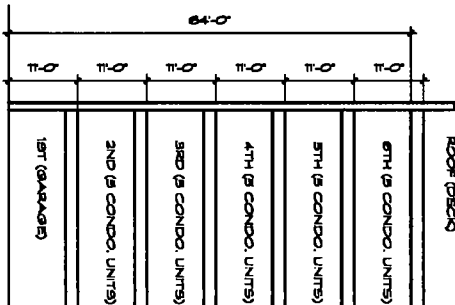

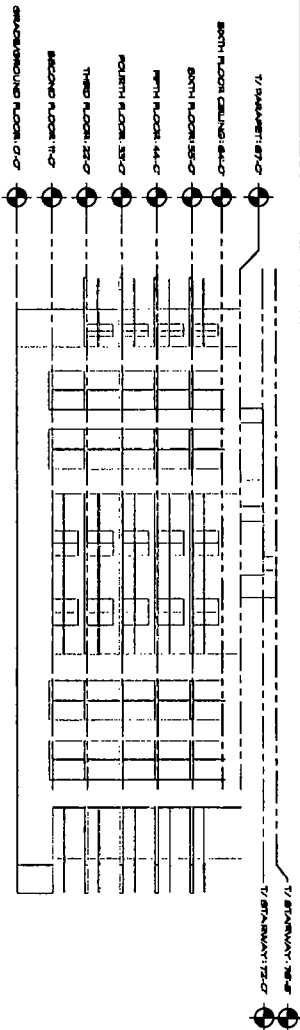

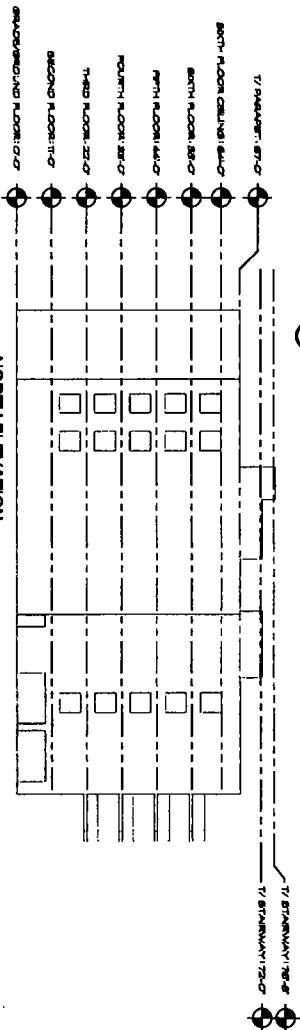

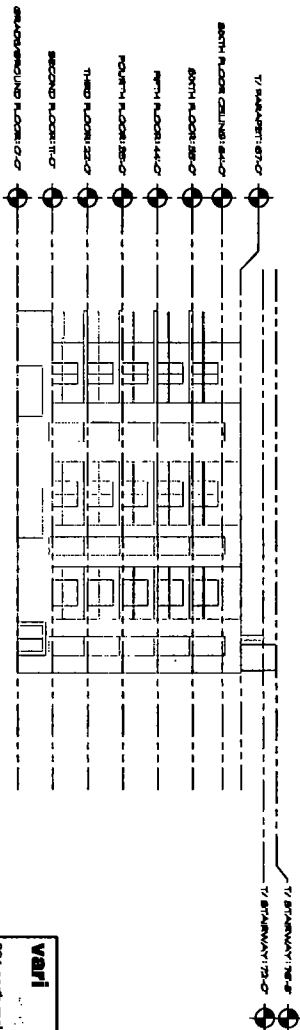
