ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District, M2-2 Light Industry District and C2-3 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 6-K in the area bounded by

West 26<sup>th</sup> Street; South Kostner Avenue; a line 724.36 feet south of and parallel to West 26<sup>th</sup> Street; a line 460 feet west of and parallel to South Kostner Avenue; a line 1067.36 feet south of and parallel to West 26<sup>th</sup> Street; South Kilbourn Avenue; a line 176.01 feet south of and parallel to the south boundary line of West 30<sup>th</sup> Street; a southwesterly line 428.79 feet long starting at a point 176.01 feet south of the south boundary line of West 30<sup>th</sup> Street (as measured along the west boundary line of South Kilbourn Avenue) and 429.87 feet west of the west line of South Kilbourn Avenue and ending at a point 1165.58 feet west of the west boundary line of South Kostner Avenue (at a point 2595.94 feet south of the south boundary line of West 26<sup>th</sup> Street); West 31<sup>st</sup> Street; a line 1239.74 feet west of and parallel to the west boundary line of South Kostner Avenue (as measured along the south boundary line of West 26<sup>th</sup> Street); a line 1065.99 feet south of and parallel to the south boundary line of West 26<sup>th</sup> Street (as measured along the west boundary line of South Kostner Avenue); a line 1206.30 feet west of and parallel to the west boundary line of South Kostner Avenue (as measured along the south boundary line of West 26<sup>th</sup> Street);

Excluding the area bounded by:

West 30<sup>th</sup> Street; a line 330.60 feet west of and parallel to the west boundary line of South Kilbourn Avenue (as measured along the south boundary line of West 30<sup>th</sup> Street); a line 100 feet south of and parallel to the south boundary line of West 30<sup>th</sup> Street; a northeasterly line starting at a point 417.24 feet west of the west boundary line of South Kilbourn Avenue and 100 feet south of the south boundary line of West 30<sup>th</sup> Street and ending at a point being 400.43 feet west of the west boundary line of South Kilbourn Avenue (as measured along the south boundary line of west 30<sup>th</sup> Street)

to those of a M1-2 Limited Manufacturing/Business Park District.

SECTION 2 Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 6-K in the area bounded by

West 26<sup>th</sup> Street; South Kostner Avenue; a line 724.36 feet south of and parallel to West 26<sup>th</sup> Street; a line 460 feet west of and parallel to South Kostner Avenue; a line 1067.36 feet south of and parallel to West 26<sup>th</sup> Street; South Kilbourn Avenue; a line 176.01 feet south of and parallel to the south boundary line of West 30<sup>th</sup> Street; a southwesterly line 428.79 feet long starting at a point 176.01 feet south of the south boundary line of West 30<sup>th</sup> Street (as measured along the west boundary line of South Kilbourn Avenue) and 429.87 feet west of the west line of South Kilbourn Avenue and ending at a point 1165.58 feet west of the west boundary line of South Kostner Avenue (at a point 2595.94 feet south of the south boundary line of West 26<sup>th</sup> Street); West 31<sup>st</sup> Street; a line 1239.74 feet west of and parallel to the west boundary line of South Kostner Avenue (as measured along the south boundary line of West 26<sup>th</sup> Street); a line 1065.99 feet south of and parallel to the south boundary line of West 26<sup>th</sup> Street (as measured along the west boundary line of South Kostner Avenue); a line 1206.30 feet west of and parallel to the west boundary line of South Kostner Avenue (as measured along the south boundary line of West 26<sup>th</sup> Street);

Excluding the area bounded by:

West 30<sup>th</sup> Street; a line 330.60 feet west of and parallel to the west boundary line of South Kilbourn Avenue (as measured along the south boundary line of West 30<sup>th</sup> Street); a line 100 feet south of and parallel to the south boundary line of West 30<sup>th</sup> Street; a northeasterly line starting at a point 417.24 feet west of the west boundary line of South Kilbourn Avenue and 100 feet south of the south boundary line of West 30<sup>th</sup> Street and ending at a point being 400.43 feet west of the west boundary line of South Kilbourn Avenue (as measured along the south boundary line of west 30<sup>th</sup> Street)

to those of an Industrial Planned Development.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.

## PLANNED DEVELOPMENT STATEMENTS

1. The area delineated herein as Planned Development Number TBD, ("Planned Development") consists of approximately 1,776,725 square feet (40.788 acres) of property which is depicted on the attached Planned Development Boundary and Property Line Map ("Property"). Unilever Manufacturing (US), Inc. is the applicant ("Applicant") for this Planned Development pursuant to authorization from the owner of the property.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Planning and Development (the "**Department**") and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of 16 Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; Site Plan; Landscape Plan; and Building Elevations (North, South, East and West) prepared by Gewalt Hamilton Associates, Lakota and SPARCH and dated [date of Plan Commission presentation], submitted herein. Full-sized copies of the Site Plan, Landscape

Plan and Building Elevations are on file with the Department. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are permitted in the area delineated herein as a TBD Planned Development: all uses allowed in the M1-2 Limited Manufacturing/Business Park District, including without limitation, artisan, limited and general manufacturing; warehousing, wholesaling and freight movement; vehicle storage and towing (including fleet storage); accessory parking and related uses. Portions of the Property may be used on an interim basis for construction staging and the storage of construction materials for the various phases of development of the Property.
6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 1,776,725 square feet.
9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.
10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and

Facility Management and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.

12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-0611-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.
13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs and conserves energy and natural resources. The Applicant will exceed the City of Chicago Stormwater Ordinance by 20%. No other sustainable development measures will be required.
15. Prior to the Part II Approval (per Section 17-13-0610 of the Zoning Ordinance) for any improvements to be located in the area designated as "Future Development Area", the Applicant shall submit a site plan, landscape plan and building elevations for review and approval by the Department. Review and approval by the Department is intended to assure that specific development components substantially conform with the Planned Development and to assist the City in monitoring ongoing development. Site Plan Approval Submittals under this Statement 15 (per Section 17-13-0800) need only include that portion of the Property for which approval is being sought by the Applicant.

No Part II Approval for any portion of the Future Development Area shall be granted until Site Plan approval has been granted. Following approval by the Department, the approved Site Plan, supporting data and materials shall be made part of the main file and shall be deemed to be an integral part of the Planned Development.

After approval of the Site Plan under this Statement 15, changes or modifications may be made pursuant to the provisions of Statement 12. In the event of any inconsistency between approved plans and the terms of the Planned Development, the terms of the Planned Development shall govern. Any Site Plan Approval Submittals shall, at a minimum, provide the following information:

- fully-dimensioned site plan (including a footprint of the proposed improvements);

- fully-dimensioned building elevations;
- fully-dimensioned landscape plan(s); and,
- statistical information applicable to the subject Future Potential Expansion Zone, including floor area, the applicable FAR, uses to be established, building heights and setbacks.

Site Plan Approval Submittals shall include all other information necessary to illustrate substantial conformance to the Planned Development.

16. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the Department shall initiate a Zoning Map Amendment to rezone the property to the M1-2 Limited Manufacturing/Business Park District.

As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about January 14, 2015, the undersigned, on behalf of Unilever Manufacturing (US), Inc. (the "Applicant"), intends to file an application to rezone the property located approximately at 4401-4559 West 26th Street; 2600-2702 South Kostner Avenue; 2740-3018 South Kilbourn Avenue; 4500-4558 West 30th Street; 4501-4559 West 30th Street, Chicago, Illinois from the M2-2 Light Industry District, M1-2 Limited Manufacturing/Business Park District and C2-3 Motor Vehicle-Related Commercial District to the M1-2 Limited Manufacturing/Business Park District, then to an Industrial Planned Development. A map of the development site is printed on the reverse side of this letter.

The development site is currently occupied by a manufacturing facility and vacant land. The application seeks approval of plans to allow the development of an expansion of the manufacturing facility, office and other uses allowed in the M1-2 Limited Manufacturing/Business Park District.

**Summary of Clinton Proceeding**

On December 5, 2013, the Applicant entered a plea agreement with the United States Attorney's Office for the District of Connecticut (USAO) and the United States Environmental Protection Agency (USEPA) related to a single incident on December 5, 2008 at its former Clinton, CT manufacturing facility. The incident involved two non-managerial wastewater operators who bypassed portions of the facility's wastewater treatment system. While the Applicant voluntarily reported the bypass, it did not notify the Connecticut Department of Energy and Environment (CT DEEP) within two hours of becoming aware of the bypass, as required by the facility's then-existing CT DEEP permit. The USEPA's investigation established that the bypass was concealed from and unknown to the Applicant's management. The Applicant is aware of no evidence that any release resulted in harm to fish, other wildlife or drinking water.

Under the terms of the agreement, the Applicant has agreed to plead guilty to two counts of violating the federal Clean Water Act and will pay a \$1 million fine. The Applicant will also make a \$3.5 million charitable donation to the Connecticut Statewide Supplemental Environmental Program. The donation will be used to: a) establish the Connecticut Resiliency and Climate Adaptation Center; and, b) fund various beneficial projects proposed by the Town of Clinton and approved by the CT DEEP. The Applicant also agreed to continue with its established program of conducting third-party inspections of each of its manufacturing facilities in the US at least once during the three-year probationary period and, will provide a report to the government describing the inspection results. The Applicant will also provide certain environmental training to facility personnel and those that advise the manufacturing locations.

Separately, the Applicant reached an agreement with the CT DEEP in connection with the State's civil enforcement proceeding stemming from the incident. As part of its agreement with the State, the Applicant will implement certain facility closure activities at its former Clinton factory. The State's \$100,000 civil penalty will be satisfied by the Applicant's payment to the Connecticut Supplemental Environmental Program.
