## **ORDINANCE**

**WHEREAS**, Sections 4-60-022 and 4-60-023 of the Municipal Code set forth restrictions on liquor sales for, respectively, consumption on premises and packaged goods; and

**WHEREAS**, For organizational efficiency and for ease of reference, sections 4-60-022 and 4-60-023 set out affected areas using a ward-based numbering system; and

**WHEREAS**, As a result of the 2010 National Decennial Census, ward boundaries in the City of Chicago were re-drawn; and

**WHEREAS**, The ordinance which re-drew the ward boundaries was passed by the City Council on January 19, 2012 and is found in the Journal of the Proceedings of that date at pages 19792 through 19849. This ordinance is numbered by the City Clerk's office as SO2012-582; and

**WHEREAS**, Subsequent to the City Council passing SO2012-582, an ordinance to make corrections to said ordinance was passed by the City Council on September 12, 2012 and is found in the Journal of the Proceedings of that date at pages 33628 through 33683. This ordinance is numbered by the City Clerk's office as O2012-5439; and

**WHEREAS**, As a consequence of re-drawing ward boundaries, numerous liquor sale restrictions in sections 4-60-022 and 4-60-023 are no longer numbered accurately according to the wards in which they are now located; and

**WHEREAS**, It is necessary and appropriate to correct these numbering inaccuracies so that the liquor sale restrictions shown in sections 4-60-022 and 4-60-023 are numbered according to the wards in which they are located; now, therefore,

### ***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

**SECTION 1.** The intent of this ordinance is solely to correct numbering errors for ease of reference, and not to reduce, increase or otherwise change the restrictions on liquor sales currently in place for consumption on premises and packaged goods.

**SECTION 2.** This ordinance sets forth only those subsections of sections 4-60-022 and 4-60-023 that are being amended, and excludes unaffected subsections for the convenience of the reader. Such excluded subsections are not intended to be amended by this ordinance.

**SECTION 3.** The subsections of sections 4-60-022 and 4-60-023 that are renumbered by this ordinance are intended to be published in proper sequential numerical order.

**SECTION 4.** This is the first in a series of ordinances to correct the numbering of liquor moratoria in 4-60-022 and 4-60-023 due to the re-drawing of ward boundaries following the 2010 National Decennial Census.

**SECTION 5.** Section 4-60-022 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and inserting the underscored language, as follows:

**4-60-022 Restrictions on additional licenses.**

Subject to the provisions of subsection 4-60-021(c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- (~~27-137~~ 1.86) On Ferdinand Street, from Ashland Avenue to Wood Street; and on Hermitage Avenue, from Ferdinand Street to Kinzie Street.
- (~~27-339~~ 1.87) On Wood Street, from Kinzie Street to Grand Avenue; and on the west side of Wood Street, from Grand Avenue to Ohio Street.
- (~~27-415~~ 1.88) On Noble Street, from Grand Avenue to Chicago Avenue.
- (~~27-416~~ 1.89) On Bishop Street, from Grand Avenue to Chicago Avenue.
- (~~27-417~~ 1.90) On Armour Street, from Grand Avenue to Chicago Avenue.
- (~~35-17~~ 1.91) On West Armitage Avenue, from North California Avenue to North Sacramento Avenue.
- (~~35-20~~ 1.92) On the south side of West Armitage Avenue, from North Kimball Avenue to North St. Louis Avenue, and on the east side of North St. Louis Avenue, from West Armitage Avenue to West Cortland Avenue.
- (~~35-29~~ 1.93) On North California Avenue, from West Bloomingdale Avenue to West Armitage Avenue.

- ~~(35-31 1.94)~~ On North California Avenue, from West Palmer Street to West Fullerton Avenue.
- ~~(35-32 1.95)~~ On North California Avenue, from West Fullerton Avenue to West Logan Boulevard.
- ~~(35-34 1.96)~~ On North Kedzie Avenue, from West Cortland Street to West Dickens Avenue.
- ~~(35-41 1.97)~~ On North Kimball Avenue, from West Cortland Street to West Dickens Avenue.
- ~~(35-53 1.98)~~ On California Avenue, from Logan Boulevard to Fullerton Avenue.

*(Omitted text is unaffected by this ordinance)*

**SECTION 6.** Section 4-60-023 of the Municipal Code of Chicago is hereby amended by deleting the language struck through and inserting the underscored language, as follows:

**4-60-023      Restrictions on additional package goods licenses.**

Subject to the provisions of subsection 4-60-021(c), no additional package goods license shall be issued for any premises located within the following areas:

- ~~(27-339 1.94)~~ On Wood Street, from Kinzie Street to Grand Avenue; and on the west side of Wood Street, from Grand Avenue to Ohio Street.

- (~~27.348~~ 1.95) On Ashland Avenue, from Walnut Street to Grand Avenue.
- (~~27.410~~ 1.96) On both sides of Chicago Avenue, from Noble Street to Greenview Avenue;  
thence on the south side only of Chicago Avenue, from Greenview Avenue to  
Ashland Avenue.
- (~~27.413~~ 1.97) On Superior Street, from Noble Street to Ashland Avenue.
- (~~27.414~~ 1.98) On Noble Street, from Grand Avenue to Chicago Avenue.
- (~~27.415~~ 1.99) On Bishop Street, from Grand Avenue to Chicago Avenue.
- (~~27.416~~ 1.100) On Armour Street, from Grand Avenue to Chicago Avenue.
