#### **SECTION 2.**

Extension to Zone #154, 6:00 P.M. to 6:00 A.M. related to the 2000 Block of W. Crystal St. (bs) (POr2010-922) (1<sup>st</sup> Ward);

#### **SECTION 3.**

Extension to Zone #154, 6:00 P.M. to 6:00 A.M. related to the 2000 Block of W. Pierce Ave. (bs) (POr2010-921) (1<sup>st</sup> Ward);

#### **SECTION 4.**

Repeal Zone #44 related to the 7400 Block of S. Euclid Ave. (PO2010-6022) (8<sup>th</sup> Ward);

#### **SECTION 5.**

Repeal Zone #1287 related to the North side of E. 61<sup>st</sup> St. from 920 thru 930 (PO2010-5906) (20<sup>th</sup> Ward);

#### **SECTION 6.**

Amend Zone #1191, 8:00 A.M. to 10:00 P.M., by striking 10:00 P.M. and inserting 10:00 A.M. related to the 8900 Block of S. Laflin St. (PO2010-5475) (21<sup>st</sup> Ward);

#### **SECTION 7.**

Extension to Zone #636 by extending (ns) 3800 Block of W. Roscoe from N. Hamlin Ave. to the first alley west thereof related to the 3700 Block of W. Roscoe Ave. (bs) between N. Hamlin Ave. N. Lawndale Ave. (3705-3752 Block of W. Roscoe Ave.) (PO2010-5512) (30<sup>th</sup> Ward);
