## **AMEND - TRAFFIC LANE - TOW/AWAY ZONE**

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

#### **SECTION 1.**

Amend ordinance passed 11-5-08, page 43746 which reads W. Randolph St. service drive (south leg) (ss) fap 22' east of N. Peoria St. tap 25' east thereof- 30 Minute Standing Zone, Use Flashing Lights. Tow Zone after 30 Minutes, 7:00 A.M. to 10:00 P.M., Monday thru Saturday by striking Use Flashing Lights;

**AND ALSO** the ordinance passed 11-5-08, page 43747 which reads N. Peoria St. (es) fap 30' south of W. Randolph St. service drive (south leg) tap 25' south thereof by striking Use Flashing Lights. 30 Minute Standing Zone, Tow Zone after 30 Minutes - 7:00 A.M. to 10:00 P.M., Monday thru Saturday 10-01193999 (PO2010-4522) (27<sup>th</sup> Ward);

#### **SECTION 2.**

Repeal ordinance passed 7-10-96, page 25167 (ws) reads N. Sacramento Ave. (es) fap 90' north of W. Belmont Ave. tap 25' north thereof - Tow Zone by striking the above 10-01565486 (PO2010-5341) (33<sup>rd</sup> Ward);

#### **SECTION 3.**

Repeal ordinance passed 3-23-94, page 47217 & 47218 which reads N. Bernard St. (es) from W. Lawrence Ave. tap 105' north thereof - Tow Zone by striking the above 10-01412782 (PO2010-4907) (39<sup>th</sup> Ward);

#### **SECTION 4.**

Repeal ordinance passed 10-7-09, page 72762 which reads N. Dearborn (es) fap 109' north of W. Oak St. tap 25' north thereof - 15 Minute Standing Zone, Use Flashing Lights - Tow Zone by striking the above 10-01564407 (PO2010-5424) (42<sup>nd</sup> Ward);

#### **SECTION 5.**

Repeal ordinance passed 11-18-09, page 76743 which reads N. Wells St. (es) fap 140' north of W. Burton Pl. tap 22' north thereof - 15 Minute Standing Zone, Use Flashing Lights, 9:00 A.M. to 9:00 P.M., Tow Zone by striking the above 10-01416222 (PO2010-4848) (43<sup>rd</sup> Ward);

**AMEND - TRAFFIC LANE - TOW/AWAY ZONE - CONT.**

**SECTION 6.**

This ordinance shall take effect and be in force hereinafter its passage and publication.


