I am writing to notify you that on behalf of my client and the Applicant, Lam Sai Ho Tong Association, I will file on or about March 6, 2015, an application for a change of zoning designation from a RT-4 Residential Two-Flat, Townhouse and Multi-Use District to a B2-3 Neighborhood Mixed-Use District under the Ordinance of the City of Chicago for the property located at 221 West 22<sup>nd</sup> Place. Chicago, Illinois, and further described as follows:


#### ZONING AND DEVELOPMENT NARRATIVE IN SUPPORT OF AN APPLICATION FOR A TYPE I MAP AMENDMENT OF THE CITY OF CHICAGO ZONING MAP FOR THE PROPERTY COMMONLY KNOWN AS 221 WEST 22<sup>ND</sup> PLACE

Applicant seeks a Type I Map Amendment of the City of Chicago Zoning Map from the current RT-4 District to that of a B2-3 District for the property commonly known as 221 West 22<sup>nd</sup> Place. The subject site measures approximately 25 feet in width by 100 feet in depth. This result in a total lot area of 2,500 square feet.

The subject consists of one lot that is improved with a single family home. Applicant seeks to demolish the existing building and improve the site with one building consisting of ground floor business use and two residential dwelling units above the ground floor. The project will provide 3 parking spaces.
