BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning

Ordinance is hereby amended by changing all of the C1-2, Neighborhood Commercial

in the area bounded by:

SECTION 2. This Ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 18, 2015 the undersigned will file an Application for a change in zoning from C1-2, Neighborhood Commercial Zoning District to B2-3, Neighborhood Mixed-Use Zoning District on behalf of the Applicant, 3108-3110 W. Walton Condominium Association, Inc. for the property located at 3108-10 West Walton Street, Chicago, Illinois.

The subject property is currently improved with a three-story multi-unit residential building. The Applicant needs a zoning change to comply with the zoning code requirements for the maximum floor area and the minimum lot area to allow conversion of 13 dwelling units to 14 dwelling units (two of the dwelling units will be located in the basement) and also to duplex first floor unit to the basement, within the existing 3 story residential building.







Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

D. It is the City's policy to make this document available to the public on its Internet site and/or upon request. Some or all of the information provided on this EDS and any attachments to this EDS may be made available to the public on the Internet, in response to a Freedom of Information Act request, or otherwise. By completing and signing this EDS, the Disclosing Party waives and releases any possible rights or claims which it may have against the City in connection with the public release of information contained in this EDS and also authorizes the City to verify the accuracy of any information submitted in this EDS.

E. The information provided in this EDS must be kept current. In the event of changes, the Disclosing Party must supplement this EDS up to the time the City takes action on the Matter.
