**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B3-5 Community Shopping District symbols and indications as shown on Map No. 7-J in the area bounded by:

North Spaulding Avenue; the public alley next northeast of North Milwaukee Avenue;  
North Sawyer Avenue; and North Milwaukee Avenue

to those of a C1-5 Neighborhood Commercial District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

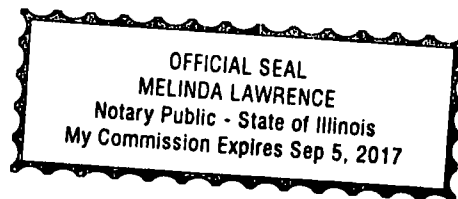


North Spaulding Avenue; the public alley next northeast of North Milwaukee Avenue; North Sawyer Avenue; and North Milwaukee Avenue
