BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the M1-2, Limited Manufacturing/Business Park District symbols as shown on Map No. 1-H in the area bounded by:

The public alley next North of and parallel to West Grand Avenue; a line 120 feet West of and parallel to North Wood Street; West Grand Avenue; a line 168 feet West of and parallel to North Wood Street.

To those of a B1-2, Neighborhood Shopping District

SECTION 2. This Ordinance takes effect after its passage and approval.
