ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-1 Residential Single-Unit (Detached House) District and B1-1 Neighborhood Shopping District symbols shown on Map 22-H in the area generally bounded by:

a line 136.19 feet north of and almost parallel to West 95th Street as measured along the east line of South Longwood Drive; the west line of the C.R.I.&P. Railroad; West 95th Street; South Longwood Drive

to the designation of B3-1 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.





The Applicant proposes to redevelop the site by demolishing the existing vacant buildings and replacing them with a new one story commercial building and approximately 19 off-street parking spaces.



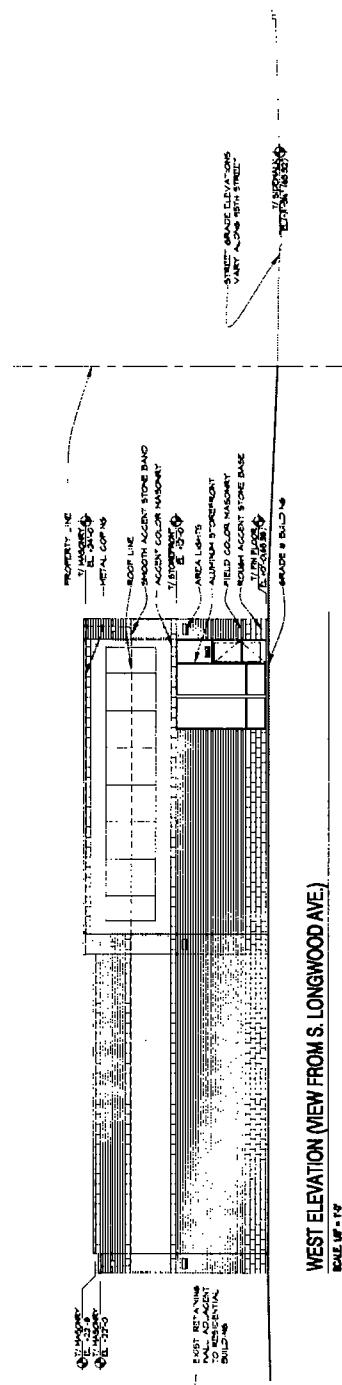

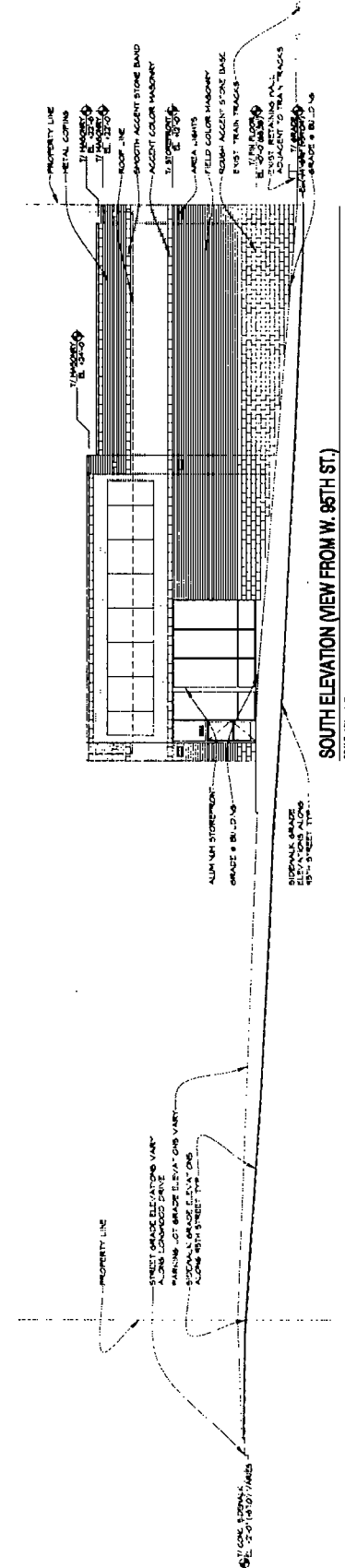


PROPOSED SITE PLAN
