ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 13-M in the area bounded by:

West Foster Avenue; North Northwest Highway; a line 114.06 southeast of West Foster Avenue, as measured along the southwesterly line of North Northwest Highway; the Chicago and Northwestern Railway right-of-way

to those of a B3-1 Community Shopping District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
